 - I want my spouse to be ordered to pay me proceeds from the sale of our home.
 - I want to remain in the marital home.
 - My spouse and I have agreed to sell our marital assets.
 - My spouse and I purchased stock together.
 - I cosigned for a loan for my spouse to pay off his/her tax liabilities.
- 4. <u>DISSOLUTION OF MARRIAGE WITHOUT CHILD(REN) OR PROPERTY</u> (12.901) packet includes petition, indigence application, notice of SSN, financial affidavit, certificate of compliance, cover sheet, notice of related cases, summons, process service memo
 - My spouse and I do not own any property jointly.
 - My spouse and I both owned home(s), car(s), boat(s), pet(s) and/or land prior to our marriage.
 - My spouse and I have agreed to resolve all of our assets and/or liabilities prior to filing for divorce.

 - My sister/brother passed away and I desire to seek custody of my niece(s)/nephew(s).
 - I have obtained parental consents from both parents to seek custody of their child(ren).
 - DCF told me to file for custody in order to enroll child in school.
 - I tried to enroll my niece(s)/nephew(s) in school and was told I need custody.
 - My sister/brother is currently incarcerated and I want custody of his/her minor child(ren).

 - My child(ren) desire to live with their father/mother.
 - My child(ren) reside with their grandparents and I want to become the primary residential parent.
- 8. <u>UNCONTESTED ANSWER FOR DISSOLUTION OF MARRIAGE WITH PROPERTY AND/OR MINOR CHILD(REN)</u> (12.903) packet includes answer, indigence application, UCCJEA affidavit, marital settlement agreements, financial affidavit, certificate of compliance
 - I was served by a private process server and/or deputy sheriff.
 - I agree with everything in the paperwork.
 - I wrote a letter requesting a court date to grant the divorce.
- 9. <u>CONTESTED ANSWER FOR DISSOLUTION OF MARRIAGE WITH PROPERTY AND/OR MINOR CHILD(REN)</u> (12.903) packet includes answer, indigence application, UCCJEA affidavit, marital settlement agreements, financial affidavit, certificate of compliance
 - I disagree with the paperwork and want to know my legal rights regarding property and/or minor child(ren) issues.
 - I will not be able to attend the final hearing.
 - I would like spousal support (alimony).

 - I need to respond to a petition for dissolution of marriage with minor or dependent children.
 - I will ask the court for something that is not contained in the petition.
- 11. <u>PATERNITY AND FOR OTHER RELATED RELIEF</u> (12.983) packet includes petition, indigence application, UCCJEA affidavit, parenting plan, notice of SSN, financial affidavit, certificate of compliance, cover sheet, notice of related cases, summons, process service memo

 - I would like the last name to be changed because I have adopted my spouse's child(ren).
