FS 318.14(10)(a) Any person who does not hold a commercial driver license or commercial learner’s permit and who is cited while driving a noncommercial motor vehicle for an offense listed under this subsection may, in lieu of payment of fine or court appearance, elect to enter a plea of nolo contendere and provide proof of compliance to the clerk of the court, designated official, or authorized operator of a traffic violations bureau. In such case, adjudication shall be withheld; however, a person may not make an election under this subsection if the person has made an election under this subsection in the preceding 12 months. A person may not make more than three elections under this subsection. If you sign this affidavit and are found to be ineligible for this option, DHSMV will suspend your license and you will be required to pay a \$7.00 fee for a supplemental report, a \$16.00 delinquent fee, and a \$60.00 license reinstatement fee to the Clerk.

***You may not make this election if you hold a CDL commercial motor vehicle license.***

If you have been issued a Uniform Traffic Citation in Leon County, Florida, for one of the following violations:

322.03, 322.065	Driver's license expired 6 months or less	Infraction
322.15	Failure to carry/display driver's license (not valid at offense date/time)	Infraction
322.34(1), 2(a), 2(b), 10(a), 10(b)	License suspended for: failure to appear, failure to pay civil penalty, attend driver improvement course, pay child support, or did not meet school attendance requirements. <b>This CANNOT be used for suspensions under FS 322.245(1)</b>	Infraction & Criminal

<b>Operating a Motor Vehicle Without a Valid Registration</b>		
320.0605, 320.07, 320.131	Operating a motor vehicle without valid registration	Infraction
FS 320.131(3) & (5)	Use of temporary tags to avoid registering a vehicle	Criminal

<b>Operating a Motor Vehicle Without Valid Insurance/Security</b>		
FS 316.646	Failure to maintain/display insurance	Infraction
