**FLORIDA COMMISSION ON OFFENDER REVIEW'S NOTICE OF  
ACTION**

Respondent, Florida Commission on Offender Review ("Commission"), by and through undersigned counsel and pursuant to this Court's September 23, 2024, Order Granting Motion for Remand, hereby submits this Notice of Action and states as follows:

1. Petitioner is seeking entitlement to mandamus relief, challenging the Commission action regarding his subsequent parole review.

2. On September 23, 2024, this Court issued its Order Granting Motion for Remand and ordered the Commission to submit a notice of action after the finalization of any action taken by the Commission.

3. On October 23, 2024, the Commission vacated the last parole interview and ordered a new subsequent parole interview covering the same seven-year period as the vacated interview through February 26, 2016, through December 15, 2022. (Exhibit A).

4. As ordered in this Court's September 23, 2024, Order Granting Remand, the Petitioner may file a response to this notice or an amendment or supplement to his petition within thirty (30) days of the filing of this Notice of Action, and the Commission shall have thirty (30) days to file a response thereto or, if Petitioner does not file a response, amendment or supplement, within fifty (50) days of the date of service of the Notice of Action.

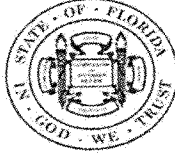

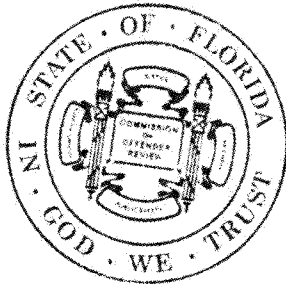
