

**JOINT COUNTY/CITY ADOPTION HEARING
2018 CYCLE COMPREHENSIVE PLAN AMENDMENTS
City Commission Chambers
June 21, 2018**

The City and County Commissions met in special joint session on June 21, 2018, in the City Hall Commission Chambers with City Commissioners Gillum, Richardson, S. Maddox, and Ziffer present; and County Commissioners N. Maddox, Dozier, Lindley and Dailey. County Commissioner Jackson participated via telephone. Also present were Interim City Manager Goad, County Administrator Long, City Attorney Jackson, members of City and County staffs, and members of the public. City Commissioner Miller and County Commissioners Desloge and Proctor were absent.

PCT201803: INTERGOVERNMENTAL COORDINATION ELEMENT

Mr. Artie White, Administrator - Comprehensive Planning, Tallahassee-Leon County Planning Department, stated he was happy to present the final amendment of the 2018 Comprehensive Plan Cycle, PCT201803: Intergovernmental Coordination Element, clarifying voting procedures and removing the restriction limiting the number of times the Comprehensive Plan can be amended annually. Mr. White advised the local planning agency had recommended approval and that the amendment was transmitted to the Florida Department of Economic Opportunity on April 10, 2018. Mr. White read the title of the City's ordinance, Ordinance No. 18-O-20, into the record. Mr. White reported it was staff's recommendation to approve the amendment.




