ADMINISTRATIVE ORDER NO: 90-17

IN RE: AFFIDAVIT OF INSOLVENCY

WHEREAS: The Public Defender of the Second Judicial Circuit has requested the establishment of uniform procedures to inquire into the financial status of defendants; and

WHEREAS: Florida Rules of Criminal Procedure 3.111 (b)(5) requires the Judge to inform the accused that if a Public Defender is appointed, a lien for the services rendered by the Public Defender may be imposed, it is therefore:


ORDERED THAT:

1. The following uniform procedures are established throughout the Second Judicial Circuit:

- (a) an affidavit of insolvency shall be prepared by the pre-trial release or book-in officer for every defendant;
- (b) the presiding judge shall inform the defendant that an lien may be imposed for the value of the Public Defender's services;
- (c) the presiding judge shall place the defendant under oath; and
- (d) the presiding judge make a complete inquiry into the defendant's finances according to Sec. 27.52(2) Fla. Stat.

2. The affidavit of insolvency shall conform to the attached exhibit, and shall be filed in the case file.
