ADMINISTRATIVE ORDER 91-05

IN RE: COURT COSTS IN GADSDEN, JEFFERSON, LEON
AND WAKULLA COUNTY TRAFFIC CASES WHERE
NO HEARING IS HELD

WHEREAS, Rule 6 470 (b), Florida Traffic Court Rules, allows imposition of costs in traffic cases, where no hearing is required or held, in excess of the amounts otherwise charged; and

WHEREAS, the Clerks of the Court in Gadsden, Jefferson, Leon and Wakulla Counties function as fee officers in their respective counties and have requested the establishment of court costs in accordance with Rule 6 470 (b), it is therefore,

ORDERED THAT.

1) Where no hearing is required or held and the offender admits the commission of the offense by paying the penalty or receiving a withheld adjudication pursuant to the provisions of Section 318.14 (9) or (10), Florida Statutes, the following cost shall be deducted from, or in the case of Section 318 14 (9) or (10) elections, be added to the penalty by the Clerks of the County Court in Gadsden, Jefferson, Leon and Wakulla counties

(a) \$3 00 for all violations of pedestrian regulations under Section 316.130 in violations of Chapter 316 by a bicyclist 14 years of age or under,

- (b) \$6.00 for all non-moving traffic infractions;
- (c) \$10.00 for all moving infractions
- 2) The sums collected shall be remitted to the Clerk's offices in Gadsden, Jefferson, Leon and Wakulla Counties as reimbursement for expenses in the administration of traffic regulations
- 3) (a) Administrative Order 90-23, in Re: Court Costs in Jefferson, Gadsden and Wakulla County Traffic Cases Where No Hearing Is Held; dated September 7, 1990, is hereby terminated and superseded by this Administrative Order
- (b) Leon County Administrative Order No 75-2 dated February 24, 1975 and all Amendments to Administrative Order No. 75-2 are hereby terminated
- 4) This order shall become effective on October 1, 1991
