IN RE: SECOND JUDICIAL CIRCUIT PRO BONO COMMITTEE

WHEREAS, the Florida Supreme Court adopted a new rule of procedure governing
pro bono service; and

WHEREAS, the Florida Supreme Court directed each judicial circuit to establish a
pro bono committee and adopt a plan for pro bono service,

it is therefore,

ORDERED THAT.

1. The Second Judicial Circuit Pro Bono Committee is hereby established and
shall be composed of the following representatives:

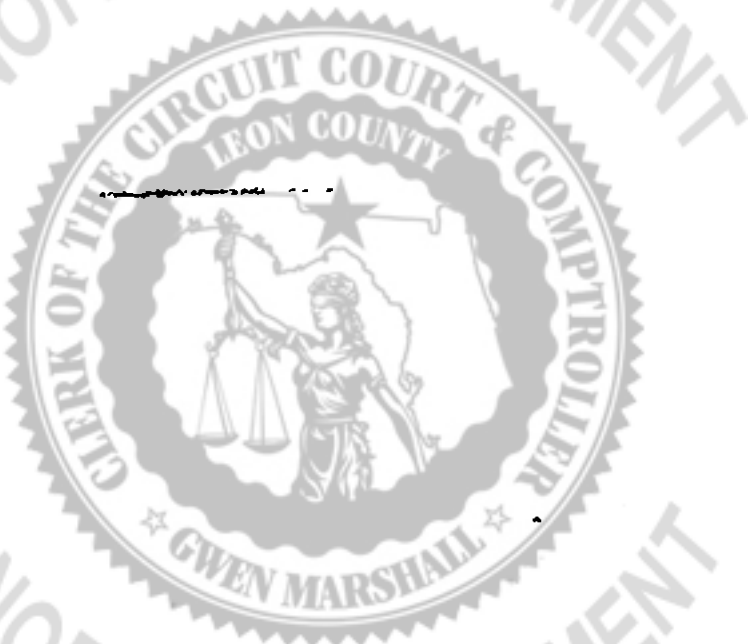

2. The Circuit Pro Bono Committee shall.

- a. Plan, develop, prepare and administer a circuit-wide pro bono attorney plan to effectuate the purposes of the rule,
- b. Establish short and long term implementation goals and objectives for its circuit pro bono plan.
- c. Prepare and submit an initial report to The Florida Bar that describes the circuit pro bono plan, the manner in which the circuit pro bono plan fulfills the standards of the rule; and the resources to be committed to increasing pro bono legal services and/or monetary contributions for legal services for the poor;
- d. Monitor and evaluate the activities, results and costs of the circuit pro bono plan;
- e. Submit an annual report to The Florida Bar as to the status, activities, results and costs of operation of the circuit pro bono plan, and
- f. Determine the particular needs of the circuit, the resources available to meet such needs, and the short and long term plans to enable lawyers to fulfill their professional responsibility of voluntary pro bono legal service to the poor

3 The circuit-wide pro bono plan should reflect the particular needs and resources of the different communities within the circuit, and should be designed to respond to such needs. The circuit pro bono plan should be designed to ensure cooperation and coordination among the providers and avoid duplication of administrative personnel.
