IN RE: **CIRCUIT AND COUNTY COURT JUDGE ASSIGNMENTS
SECOND JUDICIAL CIRCUIT**

WHEREAS, rule 2 050 (b) (4) of the Florida Rules of Judicial Administration, states that the chief judge shall assign judges to the courts and divisions and shall determine the length of each assignment;

WHEREAS, there is a need to clarify and update certain provisions of the above reference administrative order, it is therefore,

ORDERED that

Section IV-E of the above referenced Administrative Order is amended as follows

E Family Law Division

The following judges are assigned to the Family Law Division in Leon County:

- (1) **JUDGE CHARLES D MCCLURE**
- (2) **JUDGE GEORGE S REYNOLDS III**

Cases shall be distributed proportionately to the above Judges

The jurisdiction of Family Law Division shall include the following categories of cases dissolution of marriage, simplified dissolution of marriage, child custody and support, URESA, domestic violence, repeat violence, name changes, adoptions, paternity suits, parental responsibility, separate maintenance, annulment, and modification proceedings

The judges of the Leon County Court are hereby assigned to hear indirect criminal contempt proceedings arising out of domestic or repeat violence injunctions issued under the authority of Chapters 741 or 784, F S (1995)

Section IV-F of the above referenced Administrative Order is added to read as follows

"F Drug Court - Judge George S Reynolds III is assigned to preside over the Leon County Drug Court "

Section IV-G is created to read as follows

"G Criminal Intake Calendar - Judge F E Steinmeyer is assigned to handle all negotiated pleas and sentencings for the Leon County Intake Calendar In this capacity, Judge Steinmeyer shall be cross-assigned to preside over any county jurisdiction cases that are placed on the intake calendar "

Section VII Miscellaneous Assignments is amended by the creation of a new Section C which shall read as follows

"C Weekend and Holiday Duty A rotation list shall be prepared by the court administrator to designate a particular judge to serve as the duty judge on holidays and weekends The duty judge shall have the responsibility of handling all first-appearance proceedings in Leon, Gadsden, Jefferson, Wakulla, and Franklin counties The duty judge shall also handle any arrest warrants, petitions for injunction, emergency hearings or other time critical matters brought to the duty judge's attention "
