JUDICIAL CIRCUIT

WHEREAS, Rule 2.050 (b)(4) of the Florida Rules of Judicial Administration provides that the chief judge shall assign judges to the courts and divisions, and shall determine the length of each assignment and,

WHEREAS, Circuit Judge Kathleen Dekker has been appointed to the circuit court in the Second Judicial Circuit, and,

WHEREAS, there is a need to adjust the circuit court division assignments previously made to redistribute and reassign the case workload, together with all pending and previously scheduled hearings and trial dates and times associated therewith,

IT IS THEREFORE,

ORDERED THAT:

- I The Temporary Amendment of Assignments in Administrative Order No 95-03 entered August 16, 1996 shall be, and hereby is, vacated
- II Administrative Order No 95-03 is hereby amended in pertinent part, as follows

**“IV. LEON COUNTY**

**B CIVIL DIVISION**

The following judges are assigned to the Civil Division in Leon County and shall handle a proportionate share of all Leon county cases assigned to the Civil Division, together with all pending and previously scheduled hearing and trial dates and times associated therewith, including County Court Civil Appeals

1. Circuit Judge William L Gary
2. Circuit Judge Nikki Ann Clark
3. Circuit Judge Charles D McClure

Civil inmate petitions shall be proportionately assigned to Circuit Judge Nikki Ann Clark, Circuit Judge William L Gary, Circuit Judge Charles D McClure, and Circuit Judge F E Steimmeyer

**C. PROBATE DIVISION.**

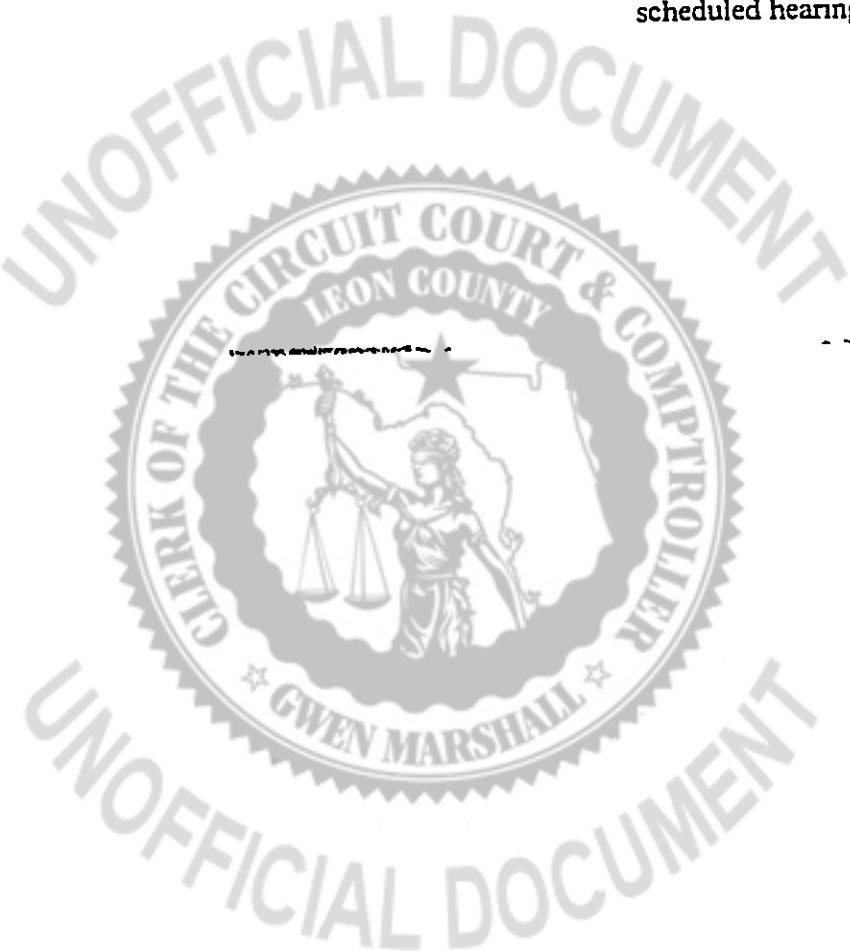
Circuit Judge F E Steimmeyer is assigned all probate cases including all competency, guardianship, substance abuse cases, and Baker Act cases, including habeas corpus actions related to Baker Act cases, together with all pending and previously scheduled hearing dates and times associated therewith previously assigned to Circuit Judge Charles D McClure and Circuit Judge George S Reynolds, III

**D JUVENILE DIVISION**

Circuit Judge Kathleen Dekker is assigned all juvenile cases, together with all pending and previously scheduled hearing and trial dates and times associated therewith

**E FAMILY LAW DIVISION**

The following judges are assigned to the Family Law Division in Leon County and shall handle a proportionate share of all Leon County cases assigned to the Family Division, together with all pending and previously scheduled hearing and trial dates and times



1. Circuit Judge John E Crusoe
2. Circuit Judge George S Reynolds, III

The jurisdiction of the Family Law Division shall include the following categories of cases dissolution of marriage, simplified dissolution of marriage, custody and support, URESA, domestic violence, repeat violence, name changes, adoptions, paternity suits, parental responsibility, separate maintenance, annulments and modification proceedings

**G CRIMINAL INTAKE CALENDAR**

Circuit Judge F E Steinmeyer is assigned to handle all negotiated pleas and sentencings for the Leon County Intake Calendar In this capacity, Circuit Judge Steinmeyer shall be cross-assigned to preside over any county jurisdiction cases that are placed on the calendar

**H LEON COUNTY STATEWIDE GRAND JURY CASES**

All statewide grand jury criminal cases are assigned to Circuit Judge F. E Steinmeyer III, together with all pending and previously scheduled hearing and trial dates and times associated therewith

**V. WAKULLA COUNTY**

Circuit Judge Charles D McClure is assigned to all Wakulla County civil, criminal, probate and juvenile cases together with all pending and previously scheduled hearings and trial dates and times associated therewith "
