TEMPORARY AMENDMENT OF  
ASSIGNMENTS IN  
ADMINISTRATIVE ORDER NO - 95-03

**IN RE: CIRCUIT AND COUNTY COURT JUDGE ASSIGNMENTS, SECOND  
JUDICIAL CIRCUIT**

**WHEREAS**, Rule 2.050(b)(4) of the Florida Rules of Judicial Administration states that the chief judge shall assign judges to the courts and divisions, and shall determine the length of each assignment, and

**WHEREAS**, Circuit Judge Philip J. Padovano was appointed to the First District Court of Appeal effective August 1, 1996, and

**WHEREAS**, there is a need to temporarily adjust the Circuit Court assignments heretofore made to distribute the cases previously assigned to Circuit Judge Padovano and Circuit Judge F. E. Steinmeyer, III, together with all pending and previously scheduled hearing and trial dates and times associated therewith,

**IT IS THEREFORE,**

**ORDERED THAT.** The above-referenced administrative order is hereby temporarily amended, in pertinent part, effective Monday August 19, 1996, as follows

**IV Leon County**

(b) Civil Division - Circuit Judge F. E. Steinmeyer, III shall be temporarily assigned to the Civil Division and shall be temporarily assigned the proportionate share of Leon County cases, including county court civil appeals, previously assigned to Circuit Judge Padovano

Civil inmate petitions hereafter filed shall be proportionately assigned to Circuit Judges Nikki Ann Clark, William L. Gary and F. E. Steinmeyer, III

(c) Probate Division - Circuit Judge Charles D. McClure shall be temporarily assigned all probate cases, together with all pending and previously scheduled hearing dates and times associated therewith, previously assigned to Circuit Judge F. E. Steinmeyer, III, with the exception of incompetency, guardianship, Baker Act and substance abuse cases. Circuit Judge George S. Reynolds, III shall be temporarily assigned all incompetency, guardianship, Baker Act and substance abuse cases, together with all pending and previously scheduled hearing dates and times associated therewith, previously assigned to Circuit Judge Steinmeyer.

(g) Criminal Intake Calendar - The County Court Administrative Judge or assigned first appearance judge shall be temporarily assigned to handle all negotiated pleas and sentencings for the Circuit Criminal Division intake calendar. In this capacity, the County Court Administrative Judge or assigned first appearance judge shall be cross-assigned to preside over any circuit jurisdiction cases that are placed on the intake calendar.

(h) Leon County Statewide Grand Jury Cases - All statewide grand jury criminal cases heretofore assigned to Circuit Judge F. E. Steinmeyer, III, shall be proportionately temporarily assigned to the Leon County Criminal Division Circuit Judges, together with all pending and previously scheduled hearing and trial dates and times associated therewith.

#### VI Wakulla County

Circuit Judge F. E. Steinmeyer, III shall be temporarily assigned to all Wakulla County civil, criminal, probate and juvenile cases, together with all pending and previously scheduled hearing and trial dates and times associated therewith, previously assigned to Circuit Judge Padovano.
