ADMINISTRATIVE ORDER NO.: 97-10

IN RE:       **LEGAL MAIL AND ADDRESS CHANGES WITH RESPECT  
TO INMATES AND OTHERS UNDER THE SUPERVISION  
OF THE FLORIDA DEPARTMENT OF CORRECTIONS**

WHEREAS, petitions for habeas corpus, mandamus, complaints and other suits by prisoners or other persons under the control and/or supervision of the Department of Corrections throughout the State of Florida filed against said Department and its personnel in the Circuit Court of the Second Judicial Circuit of Florida, have quadrupled in the last four (4) years, and

WHEREAS, the Clerks and Courts in the Second Judicial Circuit do not have the personnel and other resources to continuously reprocess returned legal mail resulting from the frequent and continuing changes in petitioner/complainant mailing addresses; to ascertain current mailing addresses; and, to remail orders and judgments to current mailing addresses, and

WHEREAS, to alleviate and eliminate the enormous volume of nonforwarded, nondelivered and returned legal mail created by the lack of available current addresses, it is necessary that the Clerks maintain in the court files current mailing addresses at all times so that legal mail may be sent directly by the Courts to petitioners/complainants without inordinate delay,

**IT IS THEREFORE,**

**ORDERED THAT**

1. All Petitioners/Complainants shall maintain, at all times while a petition/complaint is pending, a current mailing address with the Clerks of the Courts in the Second Judicial Circuit of Florida by filing a Notice of Change of Address in the form herein prescribed each time a change of address occurs after the initial filing of any petition/complaint.
2. All Case Management Orders with respect to prisoner litigation in the Second Judicial Circuit of Florida shall also require that the aforesaid Notice of Change of Address be filed. The approved form for such required Notice of Change of Address is attached hereto.

3. Prior to the mailing of any orders, writs or judgments by the Courts, the case file in the Clerks' offices shall be checked to ascertain a current address for mailing. Upon any failure to file and maintain a current address thereby resulting in the return of legal mail, such returned mail shall thereupon be placed in the court file by the Clerks and the case shall be closed without further consideration, rehearing or reconsideration.

4. Administrative Order 97-05 entered May 1, 1997 entitled

**Mailing of Court Orders and Judgments to Inmates and Others Under the Supervision of the Florida Department of Corrections,**

is hereby **SUPERSEDED, VACATED, and TERMINATED.**

5. This Order shall be posted in the inmate library of each institution within the Department of Corrections of the State of Florida.

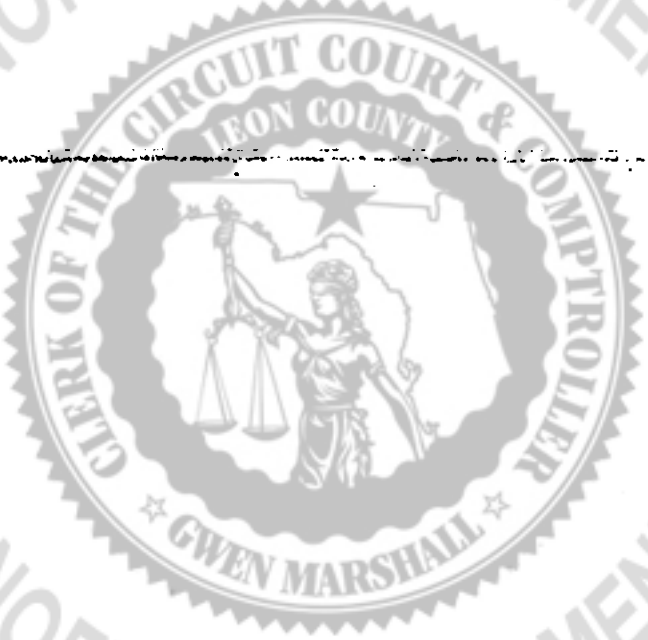
