
IN RE: APPOINTMENT OF GENERAL MASTER

WHEREAS, Rule 2.050, Florida Rules of Judicial Administration contemplates such an appointment, it is therefore,

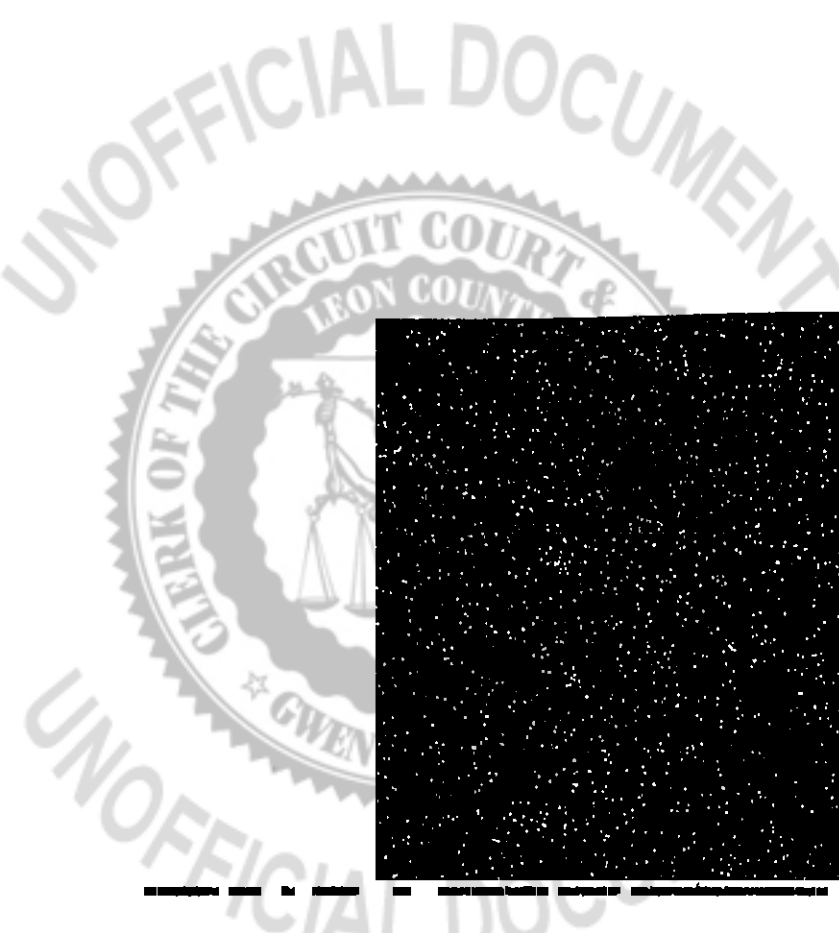

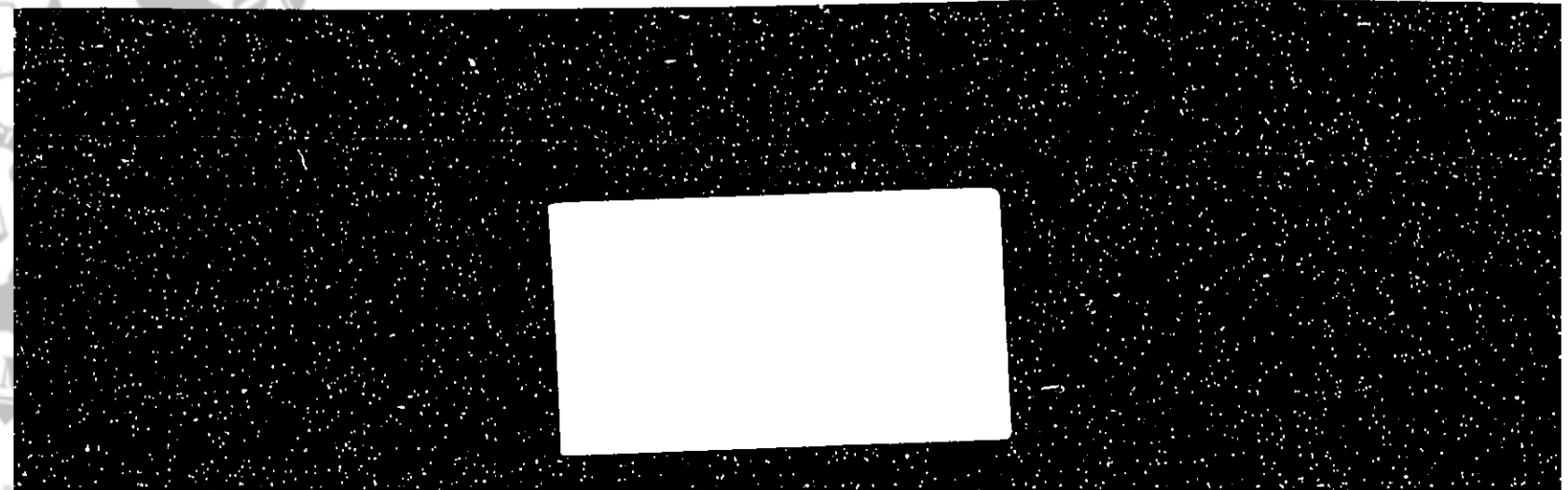
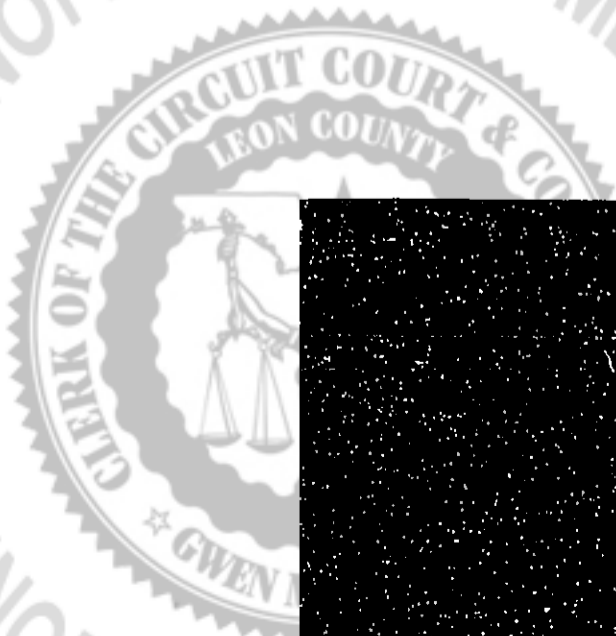
