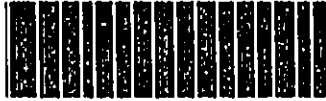

IN RE: ASSIGNMENT OF CIRCUIT COURT, CIRCUIT CIVIL DIVISION  
CASES IN LEON COUNTY

WHEREAS, the Chief Judge is charged by Fla R Jud Admin , 2 050(b)(4), with responsibility of assigning judges to the courts and divisions, and

WHEREAS, there is a desire to equitably proportion the Leon County Circuit Court Civil Division workload,

**IT IS THEREFORE, ORDERED** that:

A. Leon County Circuit Civil cases shall be assigned by category within divisions according to the type of case being filed Civil cases shall be assigned within category on the proportionate basis shown in section B and by using the following Summary Reporting System (SRS) categories adopted by the Supreme Court

1. Professional Malpractice
2. Product Liability
3. Auto Negligence
4. Other Negligence
5. Condominium
6. Contract and Indebtedness
7. Real Property and Mortgage Foreclosure
8. Eminent Domain
9. Other
  - a. Discrimination
  - b. Equitable Relief
  - c. Estreature
  - d. Foreign Judgment
  - e. Writ of Habeas Corpus
  - f. Insurance Receiverships
  - g. Petition for Delayed Birth Certificate
  - h. Writ of Mandamus - Civil Cases
  - i. Writ of Mandamus - Prisoner Cases
  - j. Alternate Writ of Mandamus
  - k. Other
10. Appeals from County Court
11. Reopen Cases

C The Clerk of Court and the Trial Court Technology Officer shall implement the necessary procedures to insure that each division is assigned cases pursuant to sections A and B above

D. For reopen cases, using the criteria shown in sections A and B above, cases with prior histories within the past two (2) years shall be assigned to the division in which the case was previously disposed. If the disposition is more than two (2) years old, then the cases shall be treated the same as a new case and assigned according to the criteria shown in sections A and B.

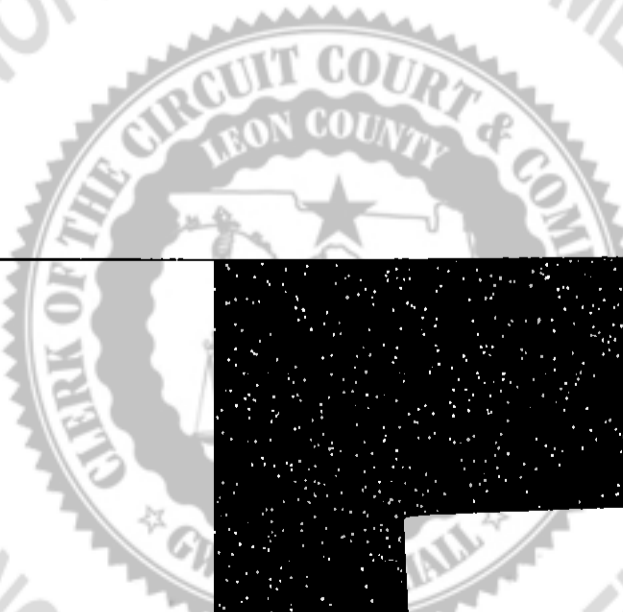
E This assignment mechanism shall take effect on November 22, 1999.
