IN RE: SECURITY PROCEDURES SUBJECT TO ELECTION PROCEEDINGS

WHEREAS, due to the extraordinary circumstances presented to Leon County in the
contested 2000 Presidential Election, and

WHEREAS, the 2000 Presidential Election court proceedings are of great public
importance; and

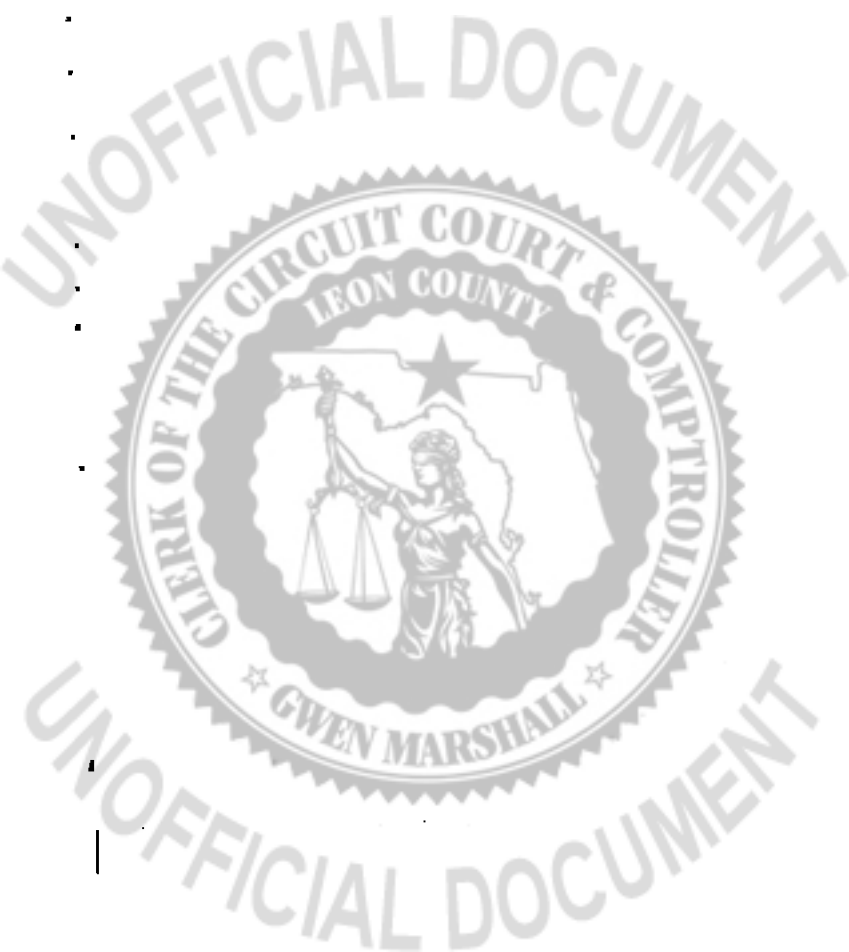
WHEREAS, there is a desire to ensure that all court proceedings are conducted in an
orderly and safe manner; and

WHEREAS, a clear policy is necessary to keep unauthorized weapons and disruptive
persons out of the courthouse, as well as provide additional security measures as needed, it is
therefore

ORDERED THAT:

1. The Sheriff of Leon County is authorized to implement any security measures
necessary to carry out appropriate security procedures in accordance with the above.
2. These procedures may include, but are not limited to, the following:
 - (A) Performing weapons' checks, including use of metal detection, at all
entrances to the Leon County Courthouse and all areas within or adjacent to the
Leon County Courthouse,
 - (B) Limiting the number of public entrances to the Leon County Courthouse,
 - (C) Limiting parking in or around the Leon County Courthouse, and


