**IN RE: CHILD SUPPORT HEARING OFFICER**

**WHEREAS**, the Florida Department of Revenue has provided funding to establish a child support hearing officer program;

**WHEREAS**, the judiciary in the Second Judicial Circuit wishes to continue the child support hearing officer program in Leon County; and

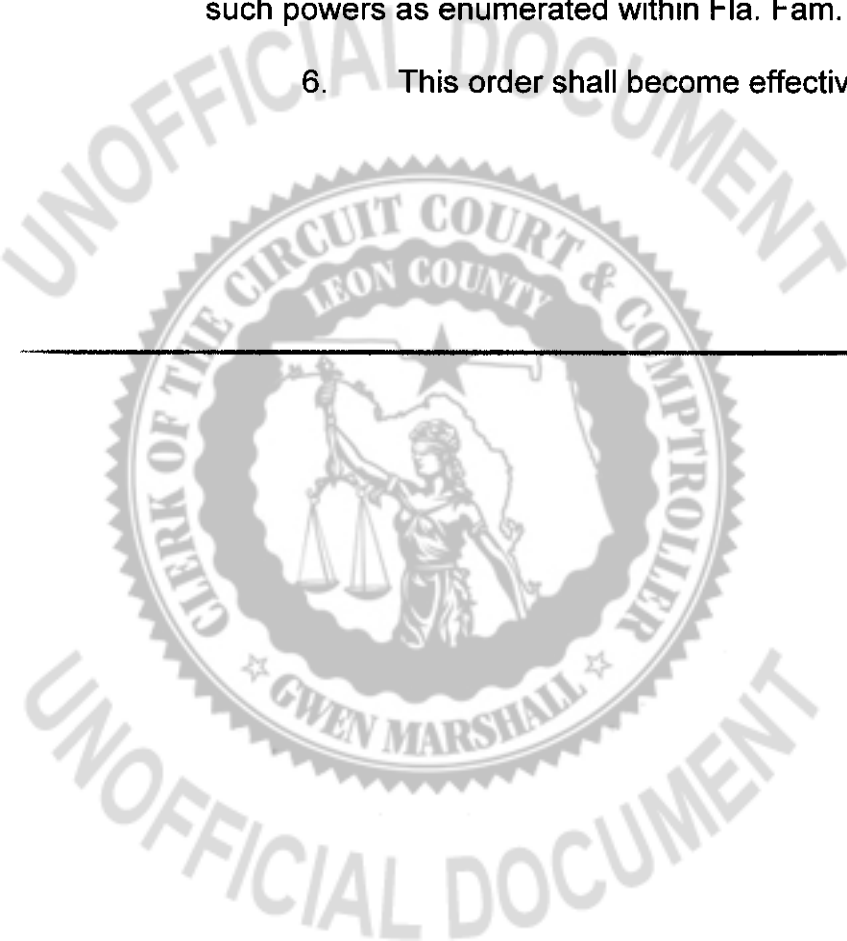
**WHEREAS**, the Leon County Board of County Commissioners has appropriated matching funds to fund a part-time child support hearing officer program in Leon County;

**IT IS THEREFORE**

**ORDERED THAT:**


1. A part-time child support hearing officer program is hereby established to handle selected Leon County child support cases.
2. Dawn Caloca-Johnson, attorney at law, is hereby appointed as part-time child support hearing officer.
3. Upon the filing of the case of action or other proceeding for the establishment, enforcement, or modification of support by the Department of Revenue wherein the party seeking support is receiving services pursuant to Title IV-D of the Social Security Act (42 U.S.C. Section 1302), or not receiving services (non IV-D proceedings), the clerk of the court of Leon County is hereby directed to refer such cases to the child support hearing officer.
4. All proceedings conducted before the child support hearing officer shall be reported by electronic recording methods pursuant to provisions of Fla.R.J.D. Admin. 2.070(c).
5. The child support hearing officer shall perform such duties and possess such powers as enumerated within Fla. Fam. Law R.P. 12.491.
6. This order shall become effective on July 1, 1999.
