ADMINISTRATIVE ORDER 1995-06
(AMENDMENT)

IN RE: COURT REPORTING SERVICES PLAN

WHEREAS, Florida Rule of Judicial Administration 2.070 (c), states, "The chief judge shall have the discretion to adopt an administrative order establishing maximum fees for court reporting services pursuant to subdivision (h)(2) . . . Such findings shall include consideration of the number of court reporters in the county or circuit, any past history of fee schedules, and any other relevant factors.", and

WHEREAS, the fee schedule has not been modified in the past and there is a need to increase fees to conform to industry standards, and

WHEREAS, the number of official court reporters of the Second Judicial Circuit is on occasion insufficient to meet the demands of the Second Judicial Circuit.

It is **THEREFORE**

ORDERED that:

1. Section II of Administrative Order 95-06 is amended to state the following.

When a court proceeding is covered by a court reporter other than an official court reporter or when a transcript is produced by a court reporter other than an official court reporter the following rates shall apply.

| Activity | Rate |

| Transcripts-Jury or Nonjury Trials or Hearing-Original | \$ 3.25 |
| Transcripts-Jury or Nonjury Trials or Hearing-Each Copy | \$ 1.50 |
