AMENDMENT TO ADMINISTRATIVE
ORDER #99-03

IN RE: ESTABLISHMENT OF FAMILY LAW ASSISTANCE PROGRAM

WHEREAS, the Supreme Court of Florida adopted Rule 12.750, Florida Family Law Rules of Procedure, which authorizes chief judges to establish self-help programs to facilitate access to family courts; and

WHEREAS, the Family Law Assistance Program of the Second Judicial Circuit was created February 12, 1999, pursuant to Administrative Order #99-03; and

WHEREAS, there is a desire on the part of the chief judge to modify the existing Administrative Order, it is therefore

ORDERED THAT Administrative Order #99-03 shall be modified as follows:

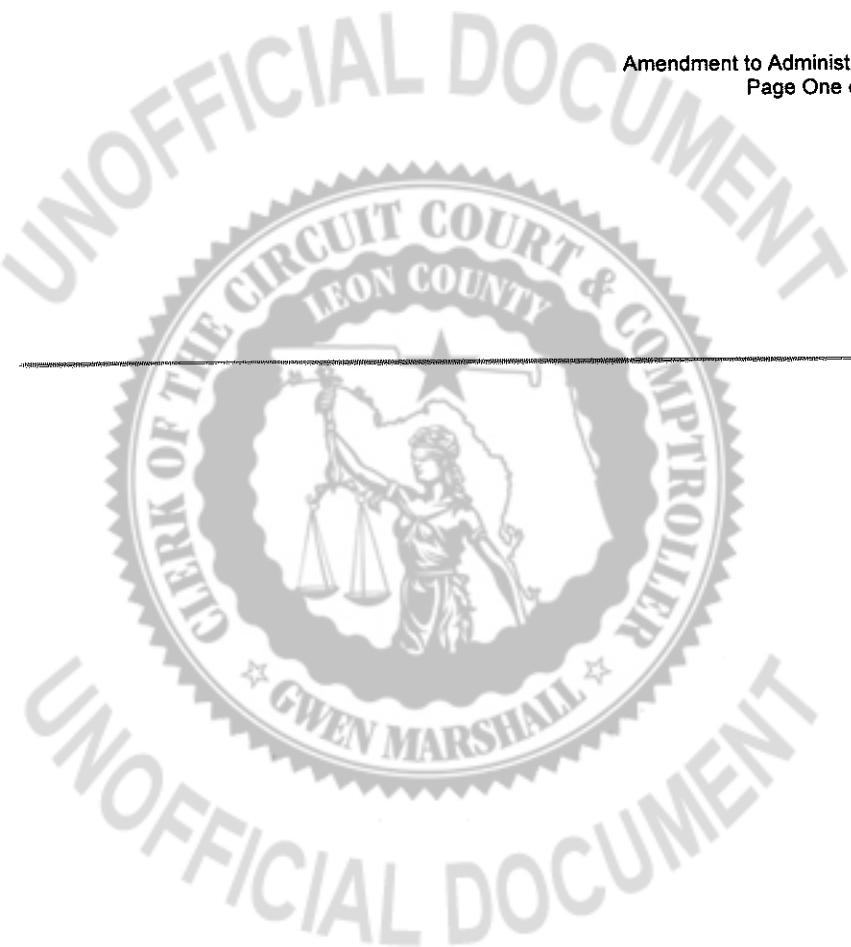
1. The Family Law Assistance Program's main office shall be physically located at the Leon County Courthouse, 301 South Monroe Street, Tallahassee, Florida 32301.
2. Family law cases include, but are not limited to, dissolution of marriage, modification, paternity, custody, spousal/separate maintenance, annulment, child support, enforcement, URESA, adoption and name change.

3. Any fees for forms and services provided by the Family Law Assistance Program shall be determined by the chief judge in a separate directive. Fees collected by the Family Law Assistance Program shall be deposited into a separate account and shall be used for the operation of the Family Law Assistance Program. Any excess fees may be used to offset the cost of the operation of the Family Mediation Services Program.
