**ADMINISTRATIVE ORDER NO. 2003-12**

**IN RE: SECOND JUDICIAL CIRCUIT PROFESSIONALISM COMMITTEE**

WHEREAS, the Supreme Court of Florida has previously mandated that the Chief Judge of each judicial circuit establish a Circuit Committee on Professionalism; and

WHEREAS, by Administrative Order dated June 11, 1998, each Chief Judge was directed to maintain in continuous operation a Circuit Committee on Professionalism; and

WHEREAS, it does not appear that there is currently a Circuit Committee on Professionalism actively operating in the Second Judicial Circuit; it is therefore

**ORDERED:**

1. The Second Judicial Circuit Committee on Professionalism is hereby reestablished effective immediately.
2. The function and purpose of the committee is to assess the status and conditions of professionalism and to encourage and promote professionalism and ethics within the Second Judicial Circuit. The committee is further charged with the responsibility of reporting to the Chief Judge on the status and conditions of professionalism in this Circuit, and with the development of programs and activities which will promote professionalism within the Circuit.
3. The committee shall consist of not less than fifteen nor more than twenty-five members who shall be appointed by the Chief Judge and serve at the pleasure of the Chief Judge. The Chair of the committee shall also be appointed by the Chief Judge and serve at the pleasure of the Chief Judge. At least one circuit judge and one county judge shall be appointed to the committee.
4. The Chair of the committee shall have the authority to designate a vice chair from the members of the committee and to establish such subcommittees as deemed appropriate in the Chair's discretion.
5. The circuit judge serving on the committee shall be the designated person responsible for the preparation of the annual report required to be submitted to the Chair of the Committee on Professionalism.

6. The committee is hereby encouraged to coordinate work with the Second Judicial Circuit Bench Bar Committee established pursuant to Administrative Order No. 2003-09.

7. The initial members of the committee shall be as set forth in Exhibit A attached to this Order.

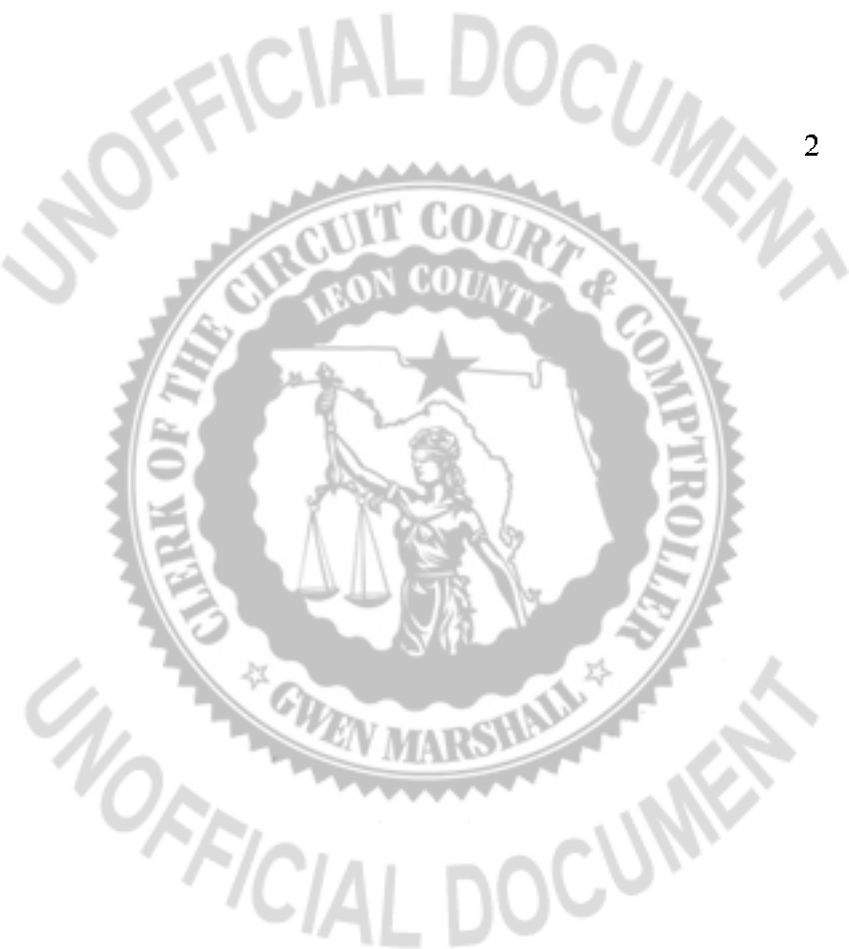
