ADMINISTRATIVE ORDER NO. 94-11

RE: INMATE PETITIONS; DOCUMENTS REQUIRED FOR DETERMINATION OF
INDIGENCY; REQUIRED COPIES FOR SERVICE ON DEFENDANTS AND
RESPONDENTS; METHODS OF CURING DEFICIENCIES

WHEREAS, Leon County is the headquarters for both the Florida
Parole Commission and the Florida Department of Corrections and,

WHEREAS, the Circuit Court for Leon County handles an extremely
large volume of petitions filed by inmates in state custody, and,

WHEREAS, the court does not have the resources to photocopy
petitions and exhibits to petitions for service with an order to show
cause or a summons and,

WHEREAS, the efficient management of cases filed by inmates in
custody requires the court to adopt administrative procedures regarding
a determination of indigency and arranging for service of process and,

WHEREAS, the efficient management of cases requires the court to
use a standard form for an inmate's financial statement.

IT IS ORDERED

1. A complaint or petition filed by an inmate in custody must be
accompanied by a sufficient number of copies for service on the
respondent or defendant. An inmate filing a complaint or petition in
this court shall transmit along with the complaint or petition one
complete copy with exhibits for each defendant or respondent to be
served.

2. An inmate filing a complaint in this court must submit the
applicable filing fee. An inmate who is unable to pay the filing fee
must submit an affidavit of insolvency, and thereafter, the clerk shall
issue a certificate of insolvency.

3. The clerk shall accept all inmate petitions and complaints
for filing regardless of any defects that may exist in the affidavit of
insolvency.

4. An inmate who has submitted a complaint or petition for filing without payment of the filing fee must submit the following documents along with the complaint or petition at the time of filing:

- (a). A Financial Affidavit. The plaintiff or petitioner must use the form attached to this administrative order. This form contains questions that pertain specifically to inmates in custody. The form must be completed, signed, and notarized.
- (b). A Certificate Regarding Inmate Account. The certificate must be signed by an officer at the institution. If the inmate has a prison bank account the certificate must include both the balance of the account at the time the certificate is signed and the average daily balance of the account for the last 3 months.
- (c). A Computer Printout Of Bank Activity. An inmate with prison bank account must also include a computer printout showing all activity in that bank account for the last 3 months.

5. If an inmate files a complaint or petition that does not comply with the provisions of this order, the court will immediately enter an order advising the inmate of the deficiency and allowing the inmate an opportunity to cure the deficiency within a reasonable time. The complaint or petition may be dismissed, in the discretion of the assigned judge, if the inmate does not cure the deficiency within the time specified by the court.

5. This order shall be posted in the inmate library of each institution within the Department of Corrections.
