ADMINISTRATIVE ORDER ON
ORGANIZATIONAL STRUCTURE OF THE
CRIMINAL DIVISION, CIRCUIT COURT, LEON COUNTY

EFFECTIVE January 6, 1987, Judges Charles D. McClure and L. Ralph Smith, will schedule and conduct trials and all pretrial and post-trial motions hearings in accordance with the below detailed structure.

1. JURORS:

A. All Jurors will be instructed in the Summons to report to Courtroom Number Three on Mondays at no later than 8:45 A.M. At that time a Judge from the Civil Division as per Order from the Chief Judge will qualify all jurors pursuant to Chapter 40, F.S.

B. After qualification those jurors required for civil trials beginning on Monday will remain with the presiding Judge having a civil trial.

C. All jurors not needed for civil trials will be sent to Courtroom Number One to begin jury selection for criminal trials.

D. Tuesday through Fridays jurors for criminal trials will be instructed to report to Courtroom Number One at 9:15 A.M. unless otherwise informed.

E. The Court Administrator will notify the jurors over the Code-a-Phone of the necessity for attendance at trials each day during the week. The Code-a-Phone shall be turned on for juror information no earlier than 5:00 P.M. on Monday through Friday of each week.

2. COURTROOMS:

A. Courtroom Number One shall be reserved each week for the Criminal Division of the Circuit Court of Leon County.

B. The Circuit Judge scheduled for criminal trials shall be assigned Courtroom Number One for the entire trial week.

Soundings, etc. shall commence in Courtroom Number One at 8:30 A.M., and conclude at 9:15 A.M.

C. The Circuit Judge in the Criminal Division set for hearings shall be assigned Courtroom Number Two. Arraignments, Pleas, sentencings, Docket Soundings, etc., shall commence in Courtroom Number Two at 8:30 A.M. and conclude at 9:15 A.M.

D. CRIMINAL TRIALS: shall be scheduled in Courtroom Number One Monday through Friday and shall commence at 9:15 A.M.

E. DOCKET SOUNDING: for each Circuit Judge assigned to the Criminal Division shall be conducted on the Friday preceding the Judges trial week and shall commence at 8:30 A.M. Docket Soundings shall be conducted by said Judge in Courtroom Number Two.

F. ARRAIGNMENTS: shall be conducted each Monday by the non-trial Circuit Judge assigned to the Criminal Division beginning at 8:30 A.M. and ending before 9:15 A.M., in Courtroom Number Two. The non-trial Judge of the Criminal Division will NOT sentence on Mondays.

G. PLEAS AND SENTENCINGS: will be conducted each morning Monday through Friday of each week between the hours of 8:30 A.M. and 9:15 A.M., unless otherwise ordered by the Court, and as excepted in Subparagraph 2(f) above. On Mondays, Arraignments will be conducted first followed by Pleas and Sentencings. Tuesdays through Fridays, Pleas will commence at 8:30 A.M., followed by Sentencings until 9:15 A.M. Sentencings Monday through Wednesdays will be only those cases involving the imposition of time to be served in the Department of Corrections. Sentencings involving non-state prison sanctions (probation, Community Control, Restitution Center, etc.) will take place if necessary on Thursdays and Fridays.

H. Trials for the month of January, 1987, will be conducted according to the attached calendars for Judges McClure and Smith. Trial and hearing weeks will be published in accordance with the monthly calendars.

I. Any Capital Punishment cases set for the months of January, February, and March will be presided over by Judge

McClure for both Divisions.

J. VIOLATIONS OF PROBATION: All non-contested Violation of Probation hearings will be set for disposition before Judge Kenneth Cooksey within ten days after a probationer has been arraigned by either of the Criminal Division Judges. Non-contested hearings will be scheduled by the State Attorney's Office and Public Defender's Office in coordination with the Probation Officer, through the Felony Division of the Clerk's Office.

Contested Violation of Probation hearings will be scheduled by the State Attorney's Office and Public Defender's Office in coordination with the probation office through the Felony Division of the Clerk's Office with Circuit Judge Kenneth Cooksey.

All Violation of Probation hearings shall be scheduled in a Courtroom to be coordinated with the Clerk and Office of Court Administrator, unless otherwise Ordered by the Court.

3. All scheduling or cancellation of hearings before either of the Judges in the Criminal Division of Circuit Court during a non-trial week shall be scheduled with the Judges Judicial Assistants and notification by the attorneys to the Felony Division of the Circuit Clerk's Office.

4. The Clerk is directed to apportion all felony cases on a fifty/fifty basis in accordance with the offense type category promulgated by the Chief Judge.

Each Judge in the Criminal Division of Circuit Court assumes the cases assigned to his Division beginning with arraignment until final disposition unless otherwise Ordered by the Court.

5. ATTORNEYS OF RECORD: in all cases where clients are in custody, shall notify the Bailiff's Office the necessity of having a prisoner at the Leon County Courthouse for trials, sentencings or hearings, requiring the custodial defendants appearance.
