IN RE: ADDITIONAL ASSIGNMENT OF CIRCUIT AND COUNTY JUDGES TO THE OTHER  
COURTS OF THE SECOND JUDICIAL CIRCUIT

WHEREAS, it is necessary to the dispatch of business in the Circuit and  
County Courts in the Second Judicial Circuit,

NOW, THEREFORE, I, J. Lewis Hall, Jr., under authority vested in me as  
Chief Judge of the Second Judicial Circuit of Florida, in accordance with  
Rule 2.050 (b) (4), Florida Rules of Judicial Administration, do hereby assign  
and designate the following judges as temporary judges of the Courts as herein  
set forth and on the dates as indicated below, unless otherwise amended. This  
assignment is for the purpose of hearing, conducting, trying and determining the  
cause or causes which shall be presented to them as temporary and acting judges  
of the designated Courts, and thereafter to dispose of all matters considered by  
them.

MAY 23, 1987 THROUGH NOVEMBER 19, 1987

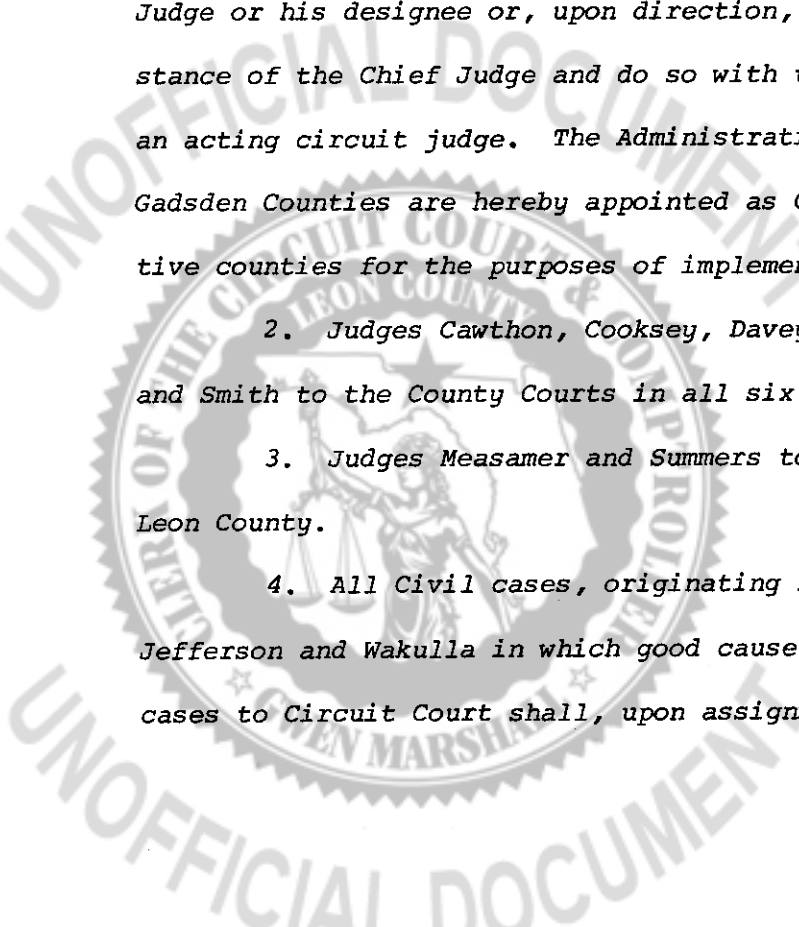
1. Judges Carter, Crusoe, Hood, Johnston, McClamma and Reynolds to  
the Circuit Court of the Second Judicial Circuit and to the County Courts in all  
six (6) counties, Second Judicial Circuit.

Said County Judges may hear, conduct and preside over Circuit  
Court cases upon oral or written request, direction or assignment from the Chief  
Judge or his designee or, upon direction, the Court Administrator at the in-  
stance of the Chief Judge and do so with the full authority and jurisdiction of  
an acting circuit judge. The Administrative judges in Jefferson, Wakulla, and  
Gadsden Counties are hereby appointed as Chief Judge designees in those respec-  
tive counties for the purposes of implementing the provisions of this order.

2. Judges Cawthon, Cooksey, Davey, Gary, Hall, Harper, McClure, Miner  
and Smith to the County Courts in all six (6) counties, Second Judicial Circuit.

3. Judges Measamer and Summers to all County Courts, five (5), except  
Leon County.

4. All Civil cases, originating in the County Courts of Leon, Gadsden,  
Jefferson and Wakulla in which good cause is shown to transfer such case or  
cases to Circuit Court shall, upon assignment as set forth above, be presided





over by the County Judge to whom such case was assigned sitting thereafter as an active Circuit Judge.

5. All criminal cases, originating in the County Courts of Leon, Gadsden, Jefferson and Wakulla in which good cause is shown to transfer such case or cases to Circuit Court, may be presided over by the County Judge to whom such case was assigned sitting thereafter as an acting Circuit Judge upon assignment by the Chief Judge of the Circuit or his designee.

These judges, under and by virtue of the authority hereof, and hereby vested with all and singular the powers and prerogatives conferred by the Constitution and Laws of the State of Florida upon a judge of the Court to which he is hereby assigned.
