


ORDER OF CERTIFICATION

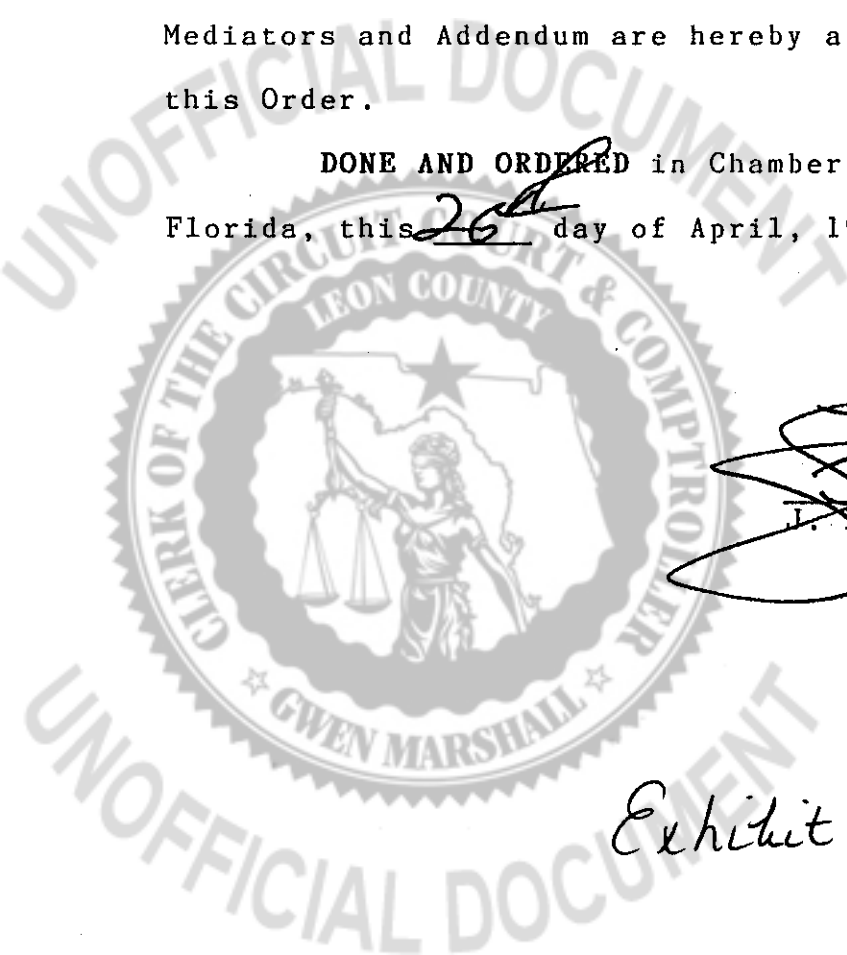
The "Grandfather" Certification Request, the proposed Mediators and Addendum are hereby attached and made a part of this Order.

1989 ADMINISTRATIVE ORDER ON MEDIATOR CERTIFICATION

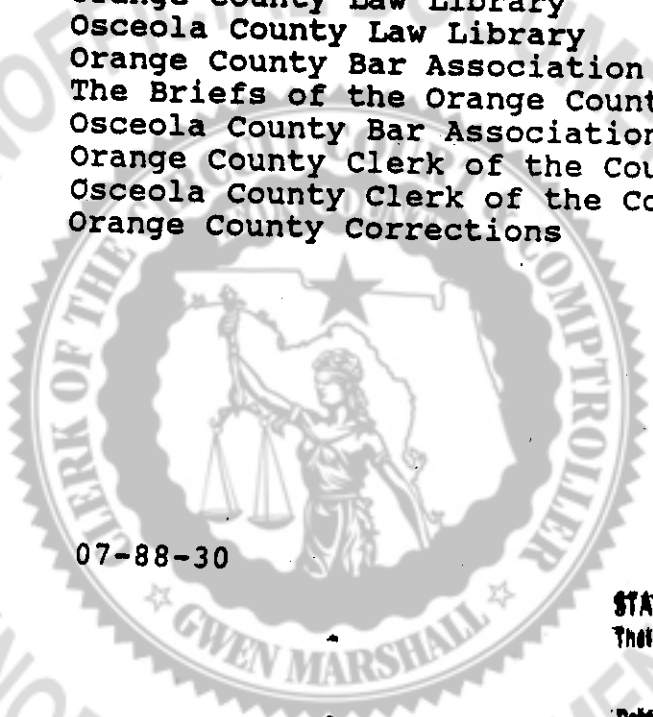
