Each Circuit Court case shall be assigned to a case load  
as set forth hereunder and reorganization of Circuit Judge  
assignments shall be as follows, effective July 1, 1989.

LEON COUNTY CIRCUIT FELONY DIVISION

JUDGE P. KEVIN DAVEY - Full Case Load "A" Assignment  
and designated Administrative Judge of Felony Division.

JUDGE PHILIP J. PADOVANO - Full Case Load "B" Assignment.

JUDGE F.E. 'TED' STEINMEYER III - Assigned in a one third  
case load to assist Divisions A & B in the taking of  
pleas, sentencings, and trials as per assignment by the  
Felony Division Administrative Judge.

LEON COUNTY CIRCUIT CIVIL

JUDGE J. LEWIS HALL, JR. - Full Case Load 01 Leon County  
Assignment and Leon County Probate.

LEON COUNTY JUDGE KATHLEEN F. DEKKER - is hereby assigned  
as a Circuit Judge to preside over all cases assigned to  
Judge Hall on uncontested divorces, name changes,  
adoptions, uncontested foreclosures spouse abuse, repeat  
violence, adoptions, and abortions.

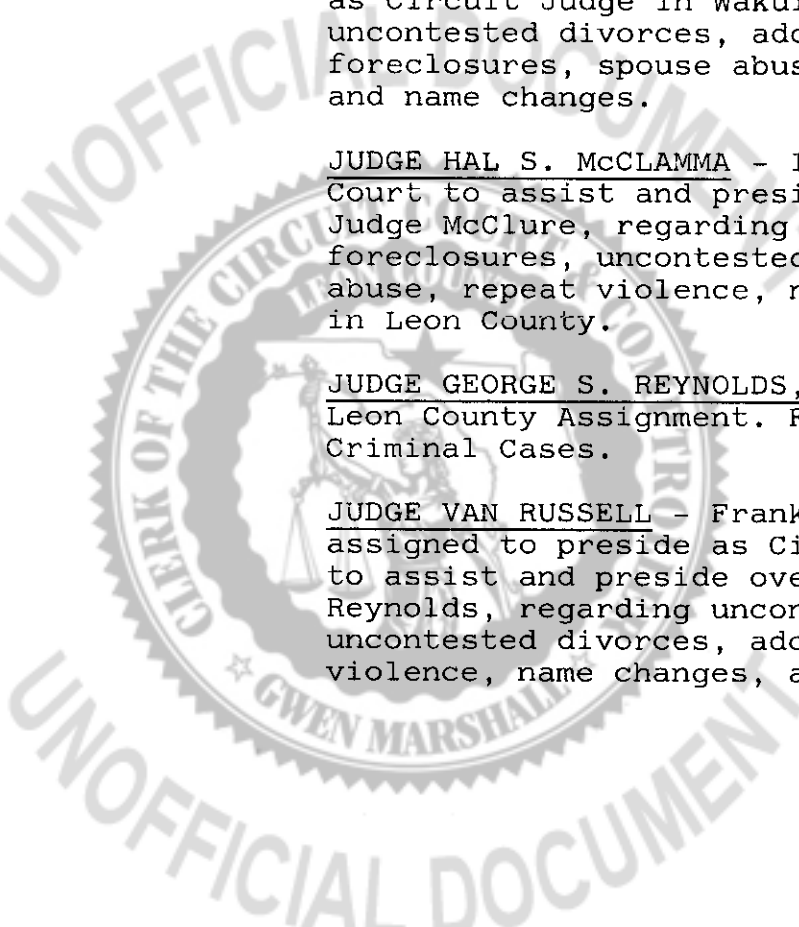
JUDGE CHARLES D. McCLURE - Full Case Load 02 Leon County  
Assignment including All URESA cases; Wakulla County  
Civil and Criminal Cases;

JUDGE J. MICHAEL CARTER - Is hereby assigned to preside  
as Circuit Judge in Wakulla County to handle all Probate,  
uncontested divorces, adoptions, uncontested mortgage  
foreclosures, spouse abuse, repeat violence, abortions,  
and name changes.

JUDGE HAL S. McCLAMMA - Is hereby assigned to Circuit  
Court to assist and preside over all cases assigned to  
Judge McClure, regarding uncontested mortgage  
foreclosures, uncontested divorces, adoptions, spouse  
abuse, repeat violence, name changes, and abortions  
in Leon County.

JUDGE GEORGE S. REYNOLDS, III. - Full Civil Case Load 03  
Leon County Assignment. Franklin County Civil and  
Criminal Cases.

JUDGE VAN RUSSELL - Franklin County Judge is hereby  
assigned to preside as Circuit Judge in Franklin County  
to assist and preside over all cases assigned to Judge  
Reynolds, regarding uncontested mortgage foreclosures,  
uncontested divorces, adoptions, spouse abuse, repeat  
violence, name changes, abortions and probate.



JUDGE JOHN E. CRUSOE - Is hereby assigned to preside as Circuit Judge in Leon County to assist Judge Reynolds in matters dealing with uncontested divorces, adoptions, uncontested mortgage foreclosures, spouse abuse, repeat violence, abortions, and name changes.

JUDGE F. E. 'TED' STEINMEYER III - Full Case Load 04 Assignment and one third Felony Assignment set forth above. Primary responsibility for Civil Assignment in Jefferson County.

A. JUDGE FELIX A. JOHNSTON, JR. - Jefferson County Judge is hereby assigned to preside on a daily basis over all Circuit proceedings in Jefferson County as a Circuit Judge until otherwise ordered by the Chief Judge, except Child Support Enforcement cases.

B. JUDGE RICHARD L. HOOD - Gadsden County Judge is hereby assigned to preside over all Child Support Enforcement cases arising out of Jefferson County and Leon County that are assigned to Judge Harper.

JUDGE WILLIAM L. GARY - One Fourth 05 Leon County Civil Assignment, excluding Jury Trial Assignment; All Civil cases arising out of Gadsden and Liberty Counties.

JUDGE L. RALPH SMITH, JR. - Is assigned all Felony cases arising out of Gadsden, Jefferson and Liberty Counties.

JUDGE GEORGE HARPER - Full Case Load Assignment in Leon County and Leon County Juvenile.

JUDGE TERRY P. LEWIS - Is hereby assigned to the Circuit Court to preside over Leon County Juvenile Court and all civil matters so assigned. Juvenile Court shall be rotated as per Leon County Court standard rotation.

GADSDEN COUNTY AND LIBERTY COUNTIES - As set forth above assigning JUDGE RALPH SMITH to full Felony assignment and JUDGE WILLIAM GARY to full Civil assignment.

WAKULLA COUNTY - JUDGE CHARLES McCLURE as set forth above to Civil and Felony Criminal case load.

FRANKLIN COUNTY - JUDGE GEORGE REYNOLDS, as set forth above.

JEFFERSON COUNTY - JUDGE RALPH SMITH, full assignment in all Felony cases and JUDGE TED STEINMEYER, full Civil case assignment as supplemented by the assignment of JUDGE FELIX JOHNSTON, set forth above.

COMPUTER PLANNING AND COORDINATION - For the Second Judicial Circuit: JUDGE HAL McCLAMMA is designated and shall recommend to the Chief Judge computer hardware, software, programming, budgeting and installation of such equipment including the proposed video communication equipment between the Leon County Courthouse and the Leon County Jail.

Each of the Circuit and County Judges in Leon, Gadsden, Jefferson, Wakulla, and Franklin Counties are hereby cross assigned to preside over any emergency within their individual counties or assignments at the Circuit or County Jurisdictional levels.

EACH ASSIGNMENT SHALL TAKE EFFECT JULY 1, 1989, UNTIL JANUARY 1, 1990, UNLESS EXTENDED OR MODIFIED THEREIN.

It is the intention of the Chief Judge to assign a third full time Circuit Judge to the Felony Division of Leon County as of January 1, 1990.

Each of the County Judges assigned herein shall establish and coordinate with the respective Circuit Judges regular schedules to accomodate their own County Court schedules and provide days certain when the Circuit Court assignments can be heard and disposed of by Final Judgment or other appropriate measures.

Each Circuit Judge assigned to a Civil or Criminal Case Load in Leon County, shall be assigned proportionately, prisoner petitions, child support, spouse abuse, repeat violence, and abortion petitions.
