IN RE: JURY MANAGEMENT POLICY

WHEREAS, by administrative order dated October 8, 1990, the Chief Justice instituted a comprehensive jury management program to reduce jury system costs and to minimize inconvenience to citizens summoned for jury service; and

WHEREAS, the Chief Judge shall have the primary responsibility for the achievement of cost savings and other goals of the jury management program; and

WHEREAS, mandatory reductions in the total jury days paid are prescribed; and

WHEREAS, effective juror management procedures require the participation and cooperation of Prosecutors, Public Defenders, Clerks and other Court officers of the courts, it is therefore

ORDERED THAT:

Section D of Administrative Order 90-14 (as amended) IN RE: Jury Management Policy, dated April 18, 1990, is amended to read as follows:

D. The panel sizes for any trial shall be as follows:

- (1) Capital Cases (in which the Death Penalty is Sought) = No Greater than 50**
- (2) Other Twelve-Person Juries and Life Felonies = No Greater than 30**
- (3) Circuit Criminal Juries = No Greater than 22**
- (4) Circuit Civil Juries = No Greater than 16**
- (5) County Court juries = No Greater than 14**

Exceptions to these panel sizes must be approved by the chief judge.

A new Section F is added to this order to read as follows:

F. A Jury Management Oversight Committee is hereby established.

- 1. The following individuals are appointed to the Committee:**
 - a. Chief Judge Charles D. McClure, Chairman**
 - b. A circuit court judge appointed by the chief judge**
 - c. A county judge appointed by the chief judge**
 - d. Nancy Daniels, Public Defender (or her designee)**
 - e. Willie Meggs, State Attorney (or his designee)**
 - f. Paul F. Hartsfield, Leon County Clerk (or his designee)**
 - g. Eleanor Hawkins, Jefferson County Clerk (or her designee)**
 - h. Duncan Hosford, Liberty County Clerk (or his designee)**
 - i. Lee Rivers, Franklin County Clerk (or his designee)**
 - j. Nicholas Thomas, Gadsden County Clerk (or his designee)**
 - k. Harold Thurmond, Wakulla County Clerk (or his designee)**
 - l. Kelly Overstreet Johnson, President of Tallahassee Bar (or her designee)**
 - m. Tom Long, Trial Court Administrator (or his designee)**

- 2. The Jury Management Oversight Committee Chairman, may, at his discretion, add other individuals or officers as members of this committee.**


- 3. The Jury Management Oversight Committee shall meet on a regular basis. The Chairman shall determine the frequency, date, time and location of the committee meetings.**

- 4. The Jury Management Oversight Committee is responsible for the following activities:**
 - a. Overseeing the progress of adherence to jury management requirements mandated by the Supreme Court.**
 - b. Identifying problems with the summoning yield and making recommendations for the resolution of such problems.**
 - c. Determining policies and procedures to enhance trial prediction.**
 - d. Establishing procedures for the implementation of prescribed panel sizes.**



- e. Assessing the need for juror orientation programs and juror questionnaires.
- f. Serving as a liaison between the various agencies involved in jury management within the circuit and other governmental or private entities including the office of the State Courts Administrator; the Supervisors of Elections, Bar Associations and Bailiffs in Franklin, Gadsden, Jefferson, Leon, Liberty and Wakulla Counties.
- g. Other activities as may be determined by the Jury Management Oversight Committee Chairman.
