SECOND JUDICIAL CIRCUIT

Each Circuit Court case shall be assigned to a case load as set forth hereunder and reorganization of Circuit Judge assignments shall be as follows, effective February 1, 1990.

I. LEON COUNTY CIRCUIT FELONY DIVISION

JUDGE PHILIP J. PADOVANO - Full Case Assignment "A" and designated Administrative Judge of Felony Division

JUDGE F. E. STEINMEYER III- Full Case Assignment "B"

II. LEON COUNTY CIRCUIT CIVIL

JUDGE J. LEWIS HALL, JR. - Three Quarter (.75) Case Assignment Leon County. Franklin County Civil and Criminal.

LEON COUNTY JUDGE KATHLEEN F. DEKKER and FRANKLIN COUNTY JUDGE VAN RUSSELL - are hereby assigned as Circuit Judges to preside over all cases assigned to Judge Hall on uncontested divorces, name changes, adoptions, uncontested foreclosures, spouse abuse, repeat violence, adoptions, and abortions.

JUDGE CHARLES D. McCLURE - Three Quarter (.75) Case Assignment Leon County, Leon County Probate; Wakulla County Criminal Cases:

LEON COUNTY JUDGE HAL S. McCLAMMA and LEON COUNTY JUDGE KATHLEEN F. DEKKER and WAKULLA COUNTY JUDGE MIKE CARTER - are hereby assigned as Circuit Judges to assist and preside over all cases assigned to Judge McClure, regarding uncontested mortgage foreclosures, uncontested divorces, adoptions, spouse abuse, repeat violence, name changes, and abortions in Leon County.

JUDGE GEORGE S. REYNOLDS, III. - Full Civil Case Assignment Leon County. Wakulla County Civil

JUDGE JOHN E. CRUSOE - One Quarter (.25) Civil Non-Jury Civil Assignment



LEON COUNTY JUDGE TERRY LEWIS and WAKULLA COUNTY JUDGE MIKE CARTER - hereby assigned to preside as Circuit Judges in Leon County and Wakulla County to assist and preside over all cases assigned to Judge Reynolds, regarding uncontested mortgage foreclosures, uncontested divorces, adoptions, spouse abuse, repeat violence, name changes, abortions and probate.

JUDGE P. KEVIN DAVEY - Three Quarter (.75) Case Assignment Leon County: and Jefferson County Civil Assignment.

LEON COUNTY JUDGE HAL S. McCLAMMA and JEFFERSON COUNTY FELIX A. JOHNSTON, JR.- are hereby assigned to preside as Circuit Judges in Leon and Jefferson Counties to assist Judge Davey in matters dealing with uncontested divorces, adoptions, uncontested mortgage foreclosures, spouse abuse, repeat violence, abortions, and name changes.

JUDGE RICHARD L. HOOD - Gadsden County Judge is hereby assigned to preside over all Child Support Enforcement cases arising out of Jefferson County that are assigned to Judge Davey.

JUDGE WILLIAM L. GARY - All Civil cases arising out of Gadsden and Liberty Counties.

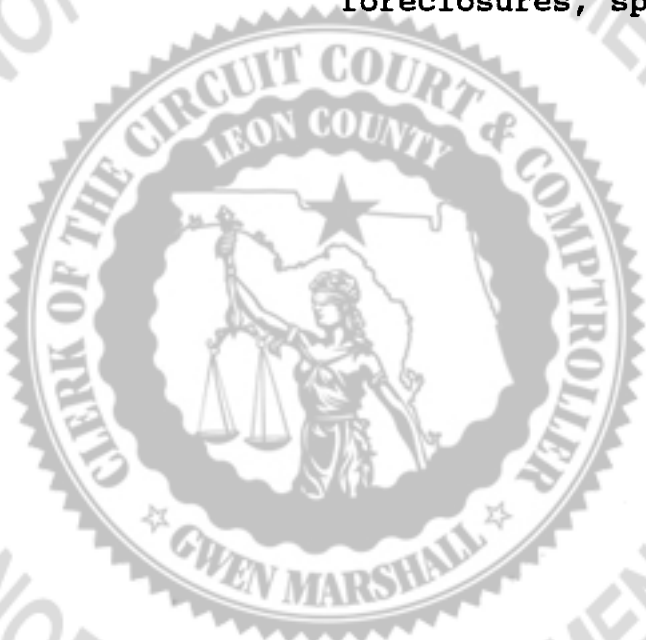
JUDGE RICHARD L. HOOD-GADSDEN COUNTY - hereby assigned to preside as Circuit Judge in Gadsden County to assist Judge Gary in matters dealing with uncontested divorces, adoptions, uncontested mortgage foreclosures, spouse abuse, repeat violence, abortions, and name changes.

JUDGE L. RALPH SMITH, JR. - is assigned all Felony cases arising out of Gadsden Jefferson and Liberty Counties.

GADSDEN COUNTY JUDGE RICHARD L. HOOD and JEFFERSON COUNTY JUDGE FELIX A. JOHNSTON, JR. are hereby assigned to preside as Circuit Judges in Gadsden and Jefferson Counties to assist Judge Smith.

JUDGE N. SANDERS SAULS - Full Case Load Assignment in Leon County

JUDGE TERRY P. LEWIS - Is hereby assigned to Circuit Court to assist in Leon County Juvenile Court and assigned to preside as Circuit Judge in Leon County to assist Judge Sauls in matters dealing with uncontested divorces, adoptions, uncontested mortgage foreclosures, spouse abuse, repeat violence,

abortions, and name changes.

COUNTY JUDGE TBA\* Is hereby assigned to preside as Circuit Judge in Leon County to assist Judge Crusoe in matters dealing with uncontested divorces, adoptions, uncontested mortgage foreclosures, spouse abuse, repeat violence, abortions and name change.

III. LEON COUNTY JUVENILE DIVISION -JUDGE JOHN A CRUSOE is assigned all Leon County Juvenile Division cases.

IV. COMPUTER PLANNING AND COORDINATION - For the Second Judicial Circuit: JUDGE HAL McCLAMMA is designated and shall recommend to the Chief Judge computer hardware, software programming, budgeting and installation of such equipment including the proposed video communication equipment between the Leon County Courthouse and the Leon County Jail.

Each circuit Judge assigned to a Leon County assignment, whether civil or criminal, shall be assigned a proportionate share of child support enforcement.

Each of the Circuit and County Judges in Leon, Gadsden, Jefferson, Wakulla, and Franklin Counties are hereby cross assigned to preside over any emergency within their individual counties or assignments at the Circuit or County Jurisdictional levels.

EACH CIRCUIT JUDGE ASSIGNMENT SHALL TAKE EFFECT FEBRUARY 1, 1990, UNTIL JANUARY 1, 1991, UNLESS EXTENDED OR MODIFIED THEREIN.

Each of the County Judges assigned herein shall establish and coordinate with the respective Circuit Judges regular schedules to accomodate their own County Court schedules and provide days certain when the Circuit Court assignments can be





heard and disposed of by Final Judgment or other appropriate measures.

Each Circuit Judge assigned to a Civil or Criminal Case Load in Leon County, shall be assigned proportionately, prisoner petitions, child support, spouse abuse, repeat violence, and abortion petitions.

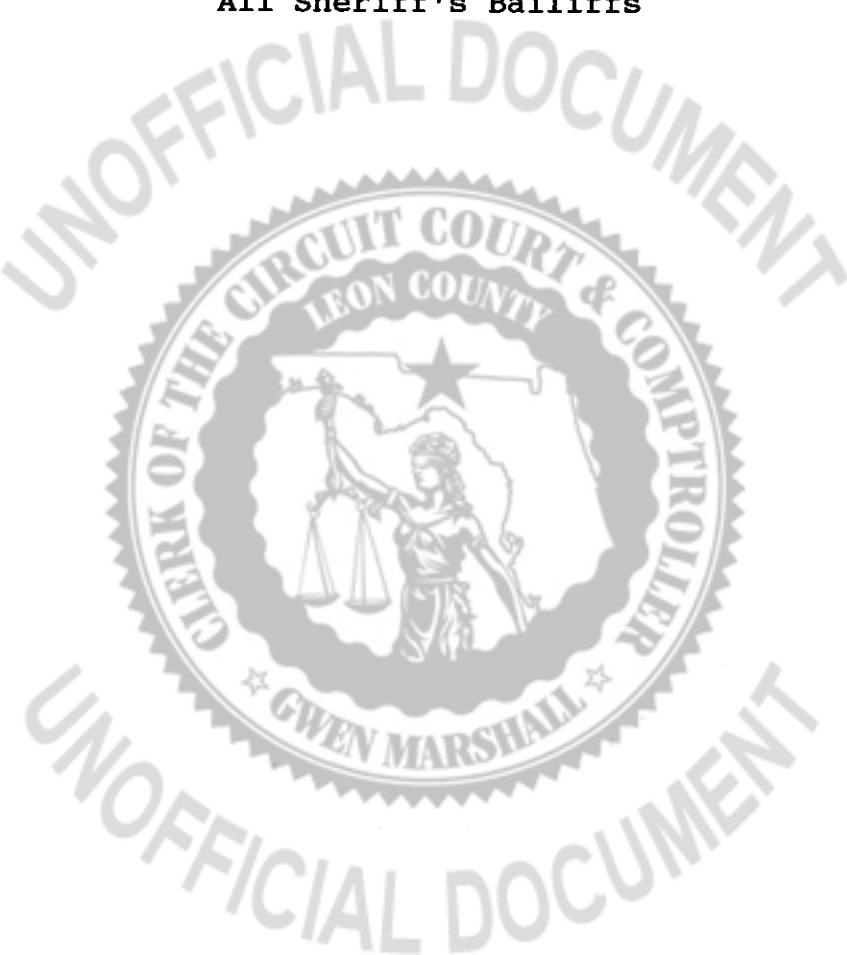
Administrative Order 89-90, dated October 12, 1989, In Re: Circuit Court Judge Assignments, Second Judicial Circuit, is hereby terminated.

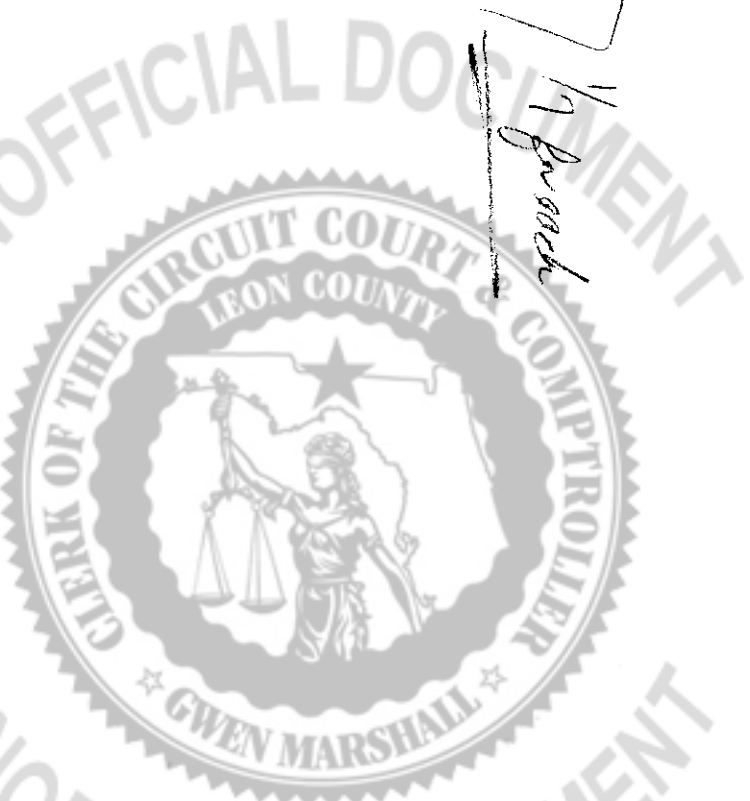
