IN RE: CIRCUIT COURT JUDGE ASSIGNMENTS
SECOND JUDICIAL CIRCUIT

Each Circuit Court case shall be assigned to a
case load as set forth hereunder and reorganization of
Circuit Judge assignments shall be as follows, effective
January 1, 1991.

I. FRANKLIN COUNTY

JUDGE J. LEWIS HALL, JR. is assigned to all
Circuit Criminal, Civil, Juvenile and Probate
cases in Franklin County.

II. GADSDEN COUNTY

A) Criminal Division - JUDGE PHILIP J. PADOVANO
is assigned to all Criminal Division cases in
Gadsden County. JUDGE N. SANDERS SAULS is
assigned as a back-up to Judge Padovano in
the Criminal Division.

B) Civil Division:

- 1) Judge PHILIP J. PADOVANO is assigned
to all Civil Division Cases except for
Child Support, Dissolution and other
Domestic Relation Cases.
- 2) Judge CHARLES D. MCCLURE is assigned
to all Child Support Cases in Gadsden
County.
- 3) JUDGE N. SANDERS SAULS is assigned to
all Dissolution and other Domestic
Relations cases in Gadsden County.

- C. Probate Division - JUDGE PHILIP J. PADOVANO is assigned to all Probate cases in Gadsden County.
- D. Juvenile Division - JUDGE JOHN E. CRUSOE is assigned to all Juvenile Cases in Gadsden County.

III. JEFFERSON COUNTY
 JUDGE P. KEVIN DAVEY is assigned to all Criminal, Civil, Juvenile and Probate cases in Jefferson County.

IV. LEON COUNTY

A) Criminal Division:

- (1) JUDGE WILLIAM L. GARY is assigned to Division "A".
- (2) JUDGE F.E. STEINMEYER III is assigned to Division "B" and is designated as Circuit Administrative Judge of the Criminal Division.

B) Civil Division:

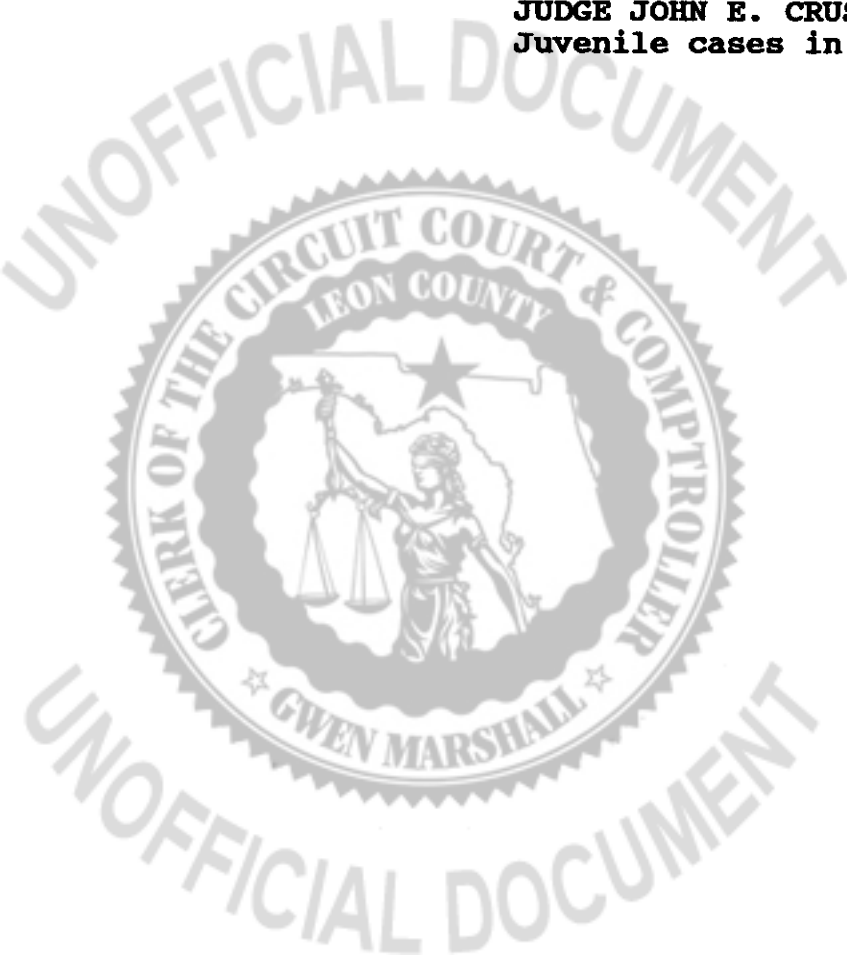
- (1) The following Judges are assigned to Civil Division in Leon County:
 JUDGE GEORGE S. REYNOLDS, III
 JUDGE L. RALPH SMITH, JR.
 JUDGE CHARLES D. MCCLURE (1/2 Civil Load)

 JUDGE J. LEWIS HALL, JR.
 JUDGE N. SANDERS SAULS
- (2) JUDGE L. RALPH SMITH is designated as Administrative Judge of the Civil Division.

C) Probate Division

JUDGE L. RALPH SMITH is assigned to all Probate cases in Leon County.

D) Juvenile Division

JUDGE JOHN E. CRUSOE is assigned to all Juvenile cases in Leon County.

- E) Each Circuit Judge assigned to a Leon County assignment, whether civil or criminal, and JUDGE RICHARD L. HOOD, Gadsden County Judge, shall be assigned a proportionate share of child support enforcement.
- F) Each Circuit Judge assigned to a Civil or Criminal Case Load in Leon County, shall be assigned proportionately, prisoner petitions, child support, spouse abuse, repeat violence, and abortion petitions.

V. LIBERTY COUNTY

- A) JUDGE N. SANDERS SAULS is assigned to all Civil, Probate and Juvenile cases in Liberty County. He shall also serve as the back-up Criminal Division Judge in Liberty County.
- B) JUDGE PHILIP J. PADOVANO is assigned to all Criminal Division cases in Liberty County.

VI. WAKULLA COUNTY

- A) JUDGE CHARLES D. MCCLURE is assigned to all Criminal Division cases in Wakulla County.
- B) JUDGE GEORGE S. REYNOLDS, III is assigned to all Civil, Juvenile and Probate cases in Wakulla County.

VII. MISCELLANEOUS ASSIGNMENTS

- A) COMPUTER PLANNING AND COORDINATION - For the Second Judicial Circuit: JUDGE HAL S. MCCLAMMA is designated and shall make recommendations to the Chief Judge on automation issues including computer hardware, soft-ware programming, budgeting and installation of such equipment.
- B) EMERGENCY MATTERS
Each of the Circuit and County Judges in Leon, Gadsden, Jefferson, Wakulla, and Franklin Counties are hereby cross assigned to preside over any emergency within their individual counties or assignments at the Circuit or County Jurisdictional levels.



Each of the County Judges Specified in Appendix 1. of this order shall establish and coordinate with the respective Circuit Judges regular Schedules to accommodate their own County Court Schedules and provide certain days when the Circuit Court assignments can be heard and disposed of by Final Judgment or other appropriate measure.
