

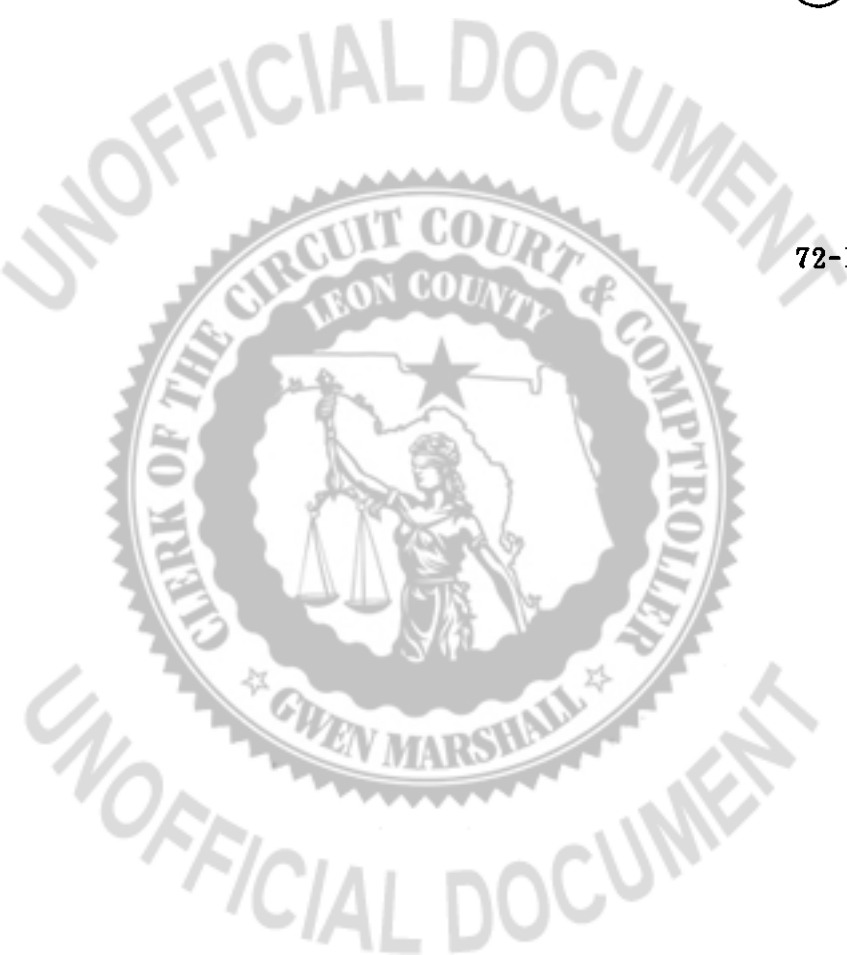
ORDERED THAT:

Section IV E. of Administrative Order 90-8, in Re: Circuit Court Judge Assignments, Second Judicial Circuit, as amended on July 2, 1990 is revised to read as follows:

"E. Each Circuit judge assigned to a Leon County assignment, whether Civil or Criminal (with the exception of Judge P. Kevin Davey), is assigned a proportionate share of Child Support Enforcement cases. Judge Richard L. Hood, Gadsden County Judge, shall also be assigned a proportionate share of Child Support Enforcement cases."
