AMENDMENT

IN RE: Public Guardianship Office,
Second Judicial Circuit

WHEREAS: Administrative Order No. 90-10, IN RE:
Public Guardianship Office, Second Judicial
Circuit, dated February 9, 1990, sets forth
various policies and procedures for the operation
of Public Guardian program; and

WHEREAS: There is a temporary need to allow a stay
of time for filing of certain reports and returns
normally due in probate involving wards of the
Public Guardian, IT IS THEREFORE

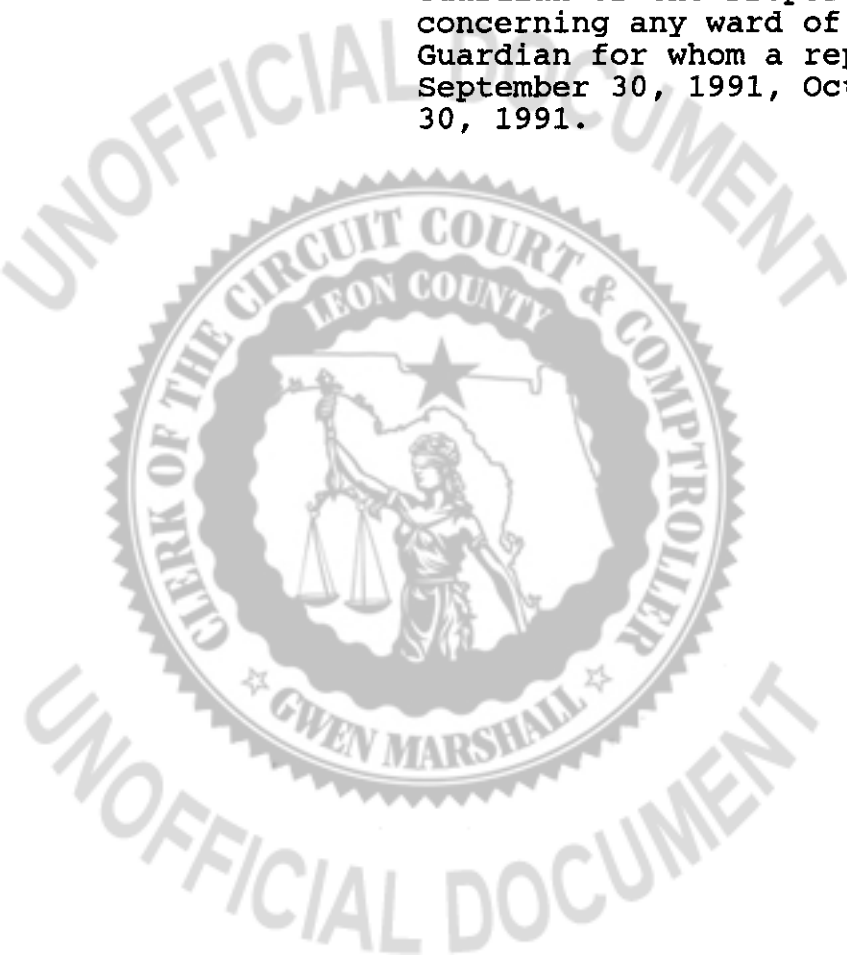
ORDERED that:

Administrative Order 90-10, IN RE: Public
Guardianship Office, Second Judicial Circuit,
dated February 9, 1991, is hereby amended by the
creation of a new Section VI which shall read as
follows:

"ESTABLISHING A TEMPORARY STAY OF TIME FOR FILING
OF CERTAIN REPORTS AND RETURNS OF PUBLIC GUARDIAN"


A. A stay of time in which to file any Annual
Report of the Guardian of the Person, Annual Return
of the Guardian of the Property or any Initial
Inventory concerning any ward of the Public Guardian
for whom an annual report, annual return, or Initial
Inventory is due on or before September 30, 1991,
October 31, 1991, for November 30, 1991 is
necessary, and, therefore, the Public Guardian is
allowed a stay of sixty (60) days from the due date
of the report in question of any Annual Report of
the Guardian of the Person, Annual Return of the
Guardian of the Property, or Initial Inventory
concerning any ward of the Office of the Public
Guardian for whom a report is due on or before
September 30, 1991, October 31, 1991, or November
30, 1991.

B. Nothing contained herein shall be construed as limiting the authority or jurisdiction of any Circuit or County Judge of the Circuit from entering an Order requiring the Public Guardian to file any report mentioned herein if the Court deems the filing of such report to be advisable or necessary.

MOTION FOR ADMINISTRATIVE ORDER ALLOWING A
STAY OF TIME IN WHICH TO FILE ANNUAL REPORTS OF THE
PERSON AND ANNUAL RETURNS OF WARDS OF THE
PUBLIC GUARDIAN, SECOND JUDICIAL CIRCUIT

The undersigned, Hugh T. Handley, Public Guardian, Second Judicial Circuit of Florida, moves the Court for an Administrative Order allowing him a stay of sixty (60) days time in which to file any Annual Report of the Guardian of the Person or any Annual Return of the Guardian of the Property or any Initial Inventory concerning any ward of the Office of the Public Guardian for whom a report is due on or before September 30, 1991, October 31, 1991 or November 30, 1991, and for good cause shows:

1. That the Office of the Public Guardian has only one secretary capable of collating and typing the aforesaid reports and that said secretary is absent from the Office of the Public Guardian because of emergency surgery and that her expected time of return to work is approximately October 31, 1991.

2. The Office of the Public Guardian has no funds with which to employ a secretarial replacement and cannot



employ temporary help because of the special training necessary regarding the reports.

WHEREFORE, Hugh T. Handley, Public Guardian, Second Judicial Circuit, requests the Court to enter an Administrative Order allowing of stay of time of sixty (60) days from the due date of any Annual Report or Annual Return or any Initial Inventory due on any of the wards of the Public Guardian for whom a report, return, or inventory is due at the end of September, 1991, the end of October, 1991 or the end of November, 1991.
