IN RE: CIRCUIT JUDGE ASSIGNMENTS SECOND JUDICIAL CIRCUIT

WHEREAS, the Second Judicial Circuit plans to implement a Family Law
Division in Leon County, effective July 1, 1992; and

WHEREAS, there is a desire to have an orderly and phased implementation of
the Family Law Division in Leon County; It is therefore,

ORDERED THAT:

Administrative Order No: 91-3, In Re: Circuit Court Judge Assignments,
Second Judicial Circuit, dated May 6, 1991 is hereby amended as follows:

I. Section IV. Leon County, Section B is amended to read as follows:

"B. Civil Division:

The following judges are assigned to the Civil Division in Leon
County and shall handle all general civil cases excluding Family
Law Division cases:

1. Judge P. Kevin Davey
2. Judge L. Ralph Smith Jr.
3. Judge F. E. Steinmeyer, III

All new Civil Division cases shall be distributed proportionately to
the above judges."

II. In Section IV, Leon County, a new Section E is created to read as follows:

"E. Family Law Division:

The following judges are assigned to the Family Law Division in Leon County:


- 1. Judge J. Lewis Hall, Jr.
- 2. Judge George S. Reynolds, III

Case shall be distributed proportionately to the above Judges.

The jurisdiction of Family Law Division shall include the following categories of cases: Dissolution of Marriage, Simplified Dissolution of Marriage, Child Custody and Support, URESA, Domestic Violence, Repeat Violence, Name Changes, Adoptions, Paternity Suits, Parental Responsibility, Separate Maintenance, Annulment, and Modification Proceedings".

III. Assignments of any new Civil or Family Division Case in Leon County, shall be made according to the above assignments effective March 1, 1992, with the exception of domestic violence and repeat violence cases shall be assigned to the Family Division on June 19, 1992. The necessary reassignments of active cases currently assigned to the five (5) Civil Division Judges shall take place on July 1, 1992.
