1. Pursuant to Section 5, Chapter 75-9, Laws of Florida, and specifically subsection (1) (b), a list of qualified attorneys is hereby prepared, after consultation with and reception of recommendations from the president of the Tallahassee Bar Association, a recognized professional legal society.
2. Said list is hereto attached, marked Exhibit A, and by reference made a part hereof.
3. In the event it becomes necessary for the Clerk of the Circuit Court to select at random attorneys from which a hearing panel member shall be selected pursuant to Section 5 (3), Chapter 75-9, each attorneys name shall be placed in a box and the requisite random selection shall be made by a blind drawing of names from the box. The names drawn shall be the panel members from which a hearing panel member shall be ultimately selected in accordance with said statute.

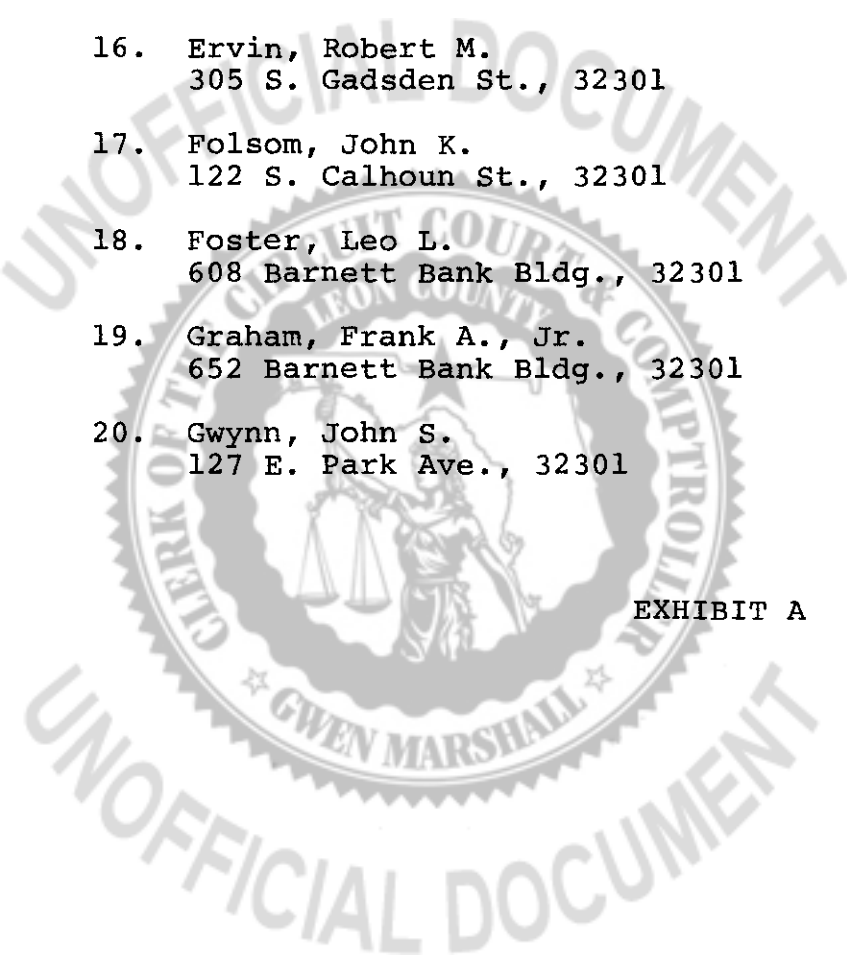
