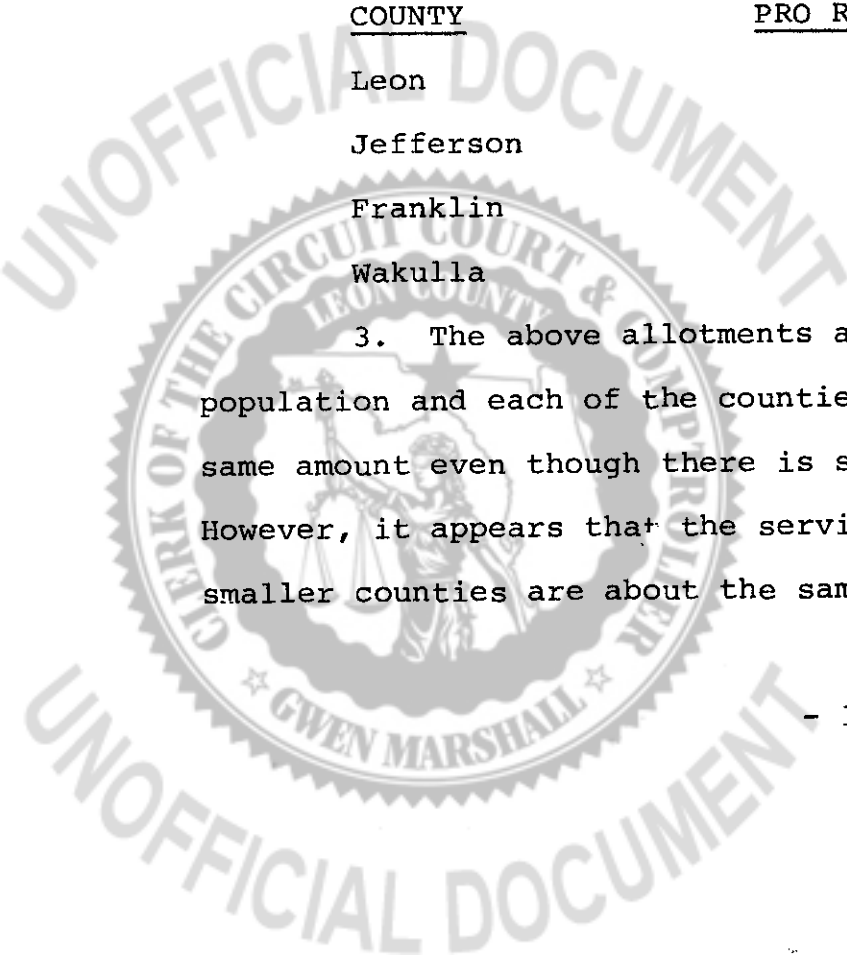
IN RE: Court Reporters' Supplement (Amendment to the Provisions of
Administrative Order No. 73-37 and 74-19).

1. By Administrative Order Numbers 73-37 and 74-19, to which references is herein made, the undersigned as Chief Judge of the Circuit, made a finding that the Official Court Reporters who were subject to and assigned to duty in the counties of Leon, Franklin, Jefferson and Wakulla were justly in need of and deserve a supplement to the extent of \$210.00 per month in order to insure competent reporting in criminal matters in said several counties. It is now apparent that since the entry of said Orders the cost of living and of supplies has greatly increased and that the case load of the respective counties are such that the services of Court Reporters are necessary to a much greater extent than in the past or that had been anticipated.

2. In view of the foregoing and of general economic conditions affecting Court Reporters and the expense of rendering their services, it is deemed that their compensation supplement should be increased to \$240.00 per month. In view of all of these circumstances it is deemed that at present a fair allotment by counties would be as follows:

<u>COUNTY</u>	<u>PRO RATA OF SALARY SUPPLEMENT</u>
Leon	\$165.00
Jefferson	25.00
Franklin	25.00
Wakulla	25.00

3. The above allotments are not strictly in proportion to population and each of the counties other than Leon will be paying the same amount even though there is some difference in their populations. However, it appears that the services of Court Reporters in the three smaller counties are about the same in time and frequency.

4. The reporters deemed to be entitled to such supplements are: Mrs. Jada Dolcater, Mrs. Betty Kirkland, Miss Frances Thigpen, Mrs. Loretta White, Margie Frohock and Arthur Green.

5. Accordingly it is found and determined that the counties of Leon, Jefferson, Franklin and Wakulla are obligated to pay to each of the Official Court Reporters listed in the preceeding paragraph the sum that is set forth in paragraph 2, commencing October 1, 1976.

6. All provisions of Administrative Order Numbers 73-37 and 74-19, except herein modified, are by reference made a part hereof and shall remain in effect.

7. A signed copy of this Order shall be furnished each Clerk of the Circuit Court in the counties involved and they shall cause it to be recorded in the appropriate records of their said counties.
