RE: List of Physicians for Service on Medical Liability  
Mediation Panel pursuant to Section 5, Chapter 75-9,  
Laws of Florida (Medical Malpractice Reform Act of 1975)

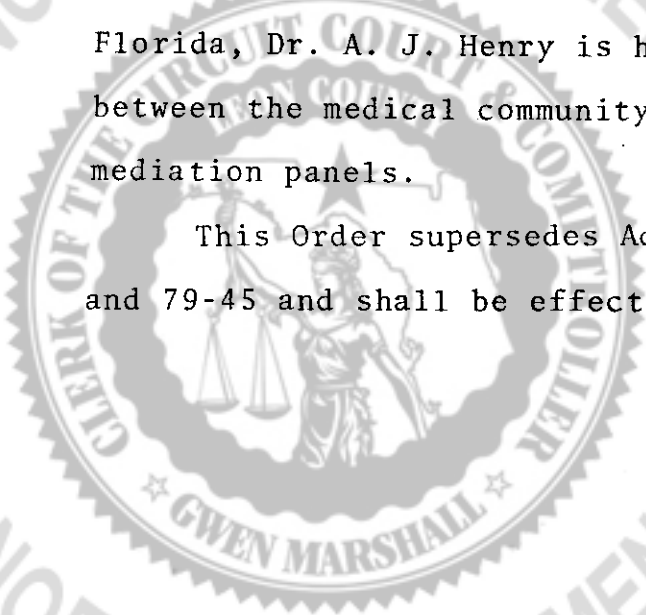
1. Pursuant to Section 5, Chapter 75-9, Laws of Florida,  
and specifically subsection (1)(a), a list of qualified physicians  
is hereby prepared, after consultation with and reception of  
recommendations from the President of the Capital Medical Society,  
Tallahassee, Florida, a recognized professional medical society.

2. Said list is hereto attached, marked Exhibit A, and by  
reference made a part hereof.

3. In the event it becomes necessary for the Clerk of the  
Circuit Court to select at random physicians from which a hearing  
panel member shall be selected pursuant to Section 5(3), Chapter 75-9,  
each physician's name according to his speciality shall be placed  
in a box and the requisite random selection shall be made by a  
blind drawing of names from the box. Those names drawn shall be  
the panel members from which a hearing panel member shall be  
ultimately selected in accordance with said statute, according to  
their speciality and in accordance with the claim so far as can  
be reasonably done.

4. At the request of The Capital Medical Society, Tallahassee,  
Florida, Dr. A. J. Henry is hereby appointed to serve as liaison  
between the medical community and the courts with reference to  
mediation panels.

This Order supersedes Administrative Order Numbers 79-41  
and 79-45 and shall be effective retroactive to February 1, 1980.



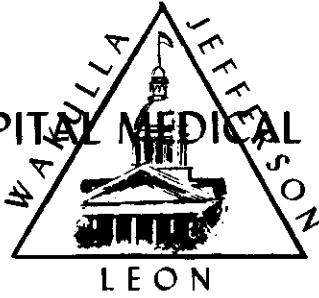

Dear Judge Willis:

At the recent meeting of the Board of Governors of the Capital Medical Society, criteria for physician eligibility service on mediation panels was reviewed.

As you will recall, the previous criteria specified that eligibility would be limited to physicians in active practice who were board certified and had practiced in this community for a minimum of five years.

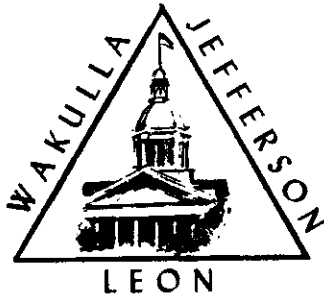
It has come to our attention that this criteria severely restricts the number of physicians to whom the Court has access and has the potential of inhibiting the mediation process.

Therefore, a review of our membership has been conducted and we are pleased to enclose a considerably expanded list of eligible physicians. This review process will continue at intervals throughout the year and you will be provided with the names of additional physicians as they become eligible.

We would also like to offer the name of Dr. A.J. Henry who has agreed to act as a liaison between the medical community and the Court with reference to mediation panels.

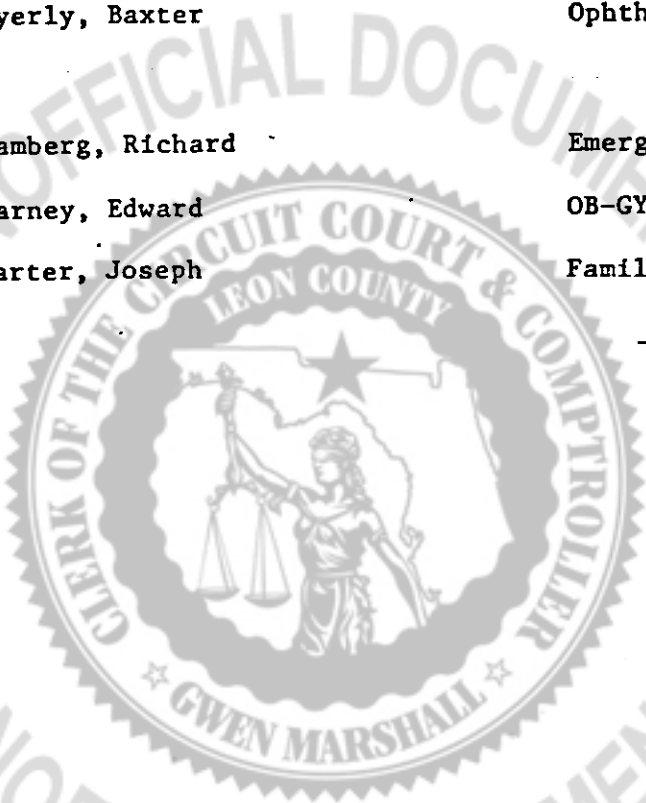

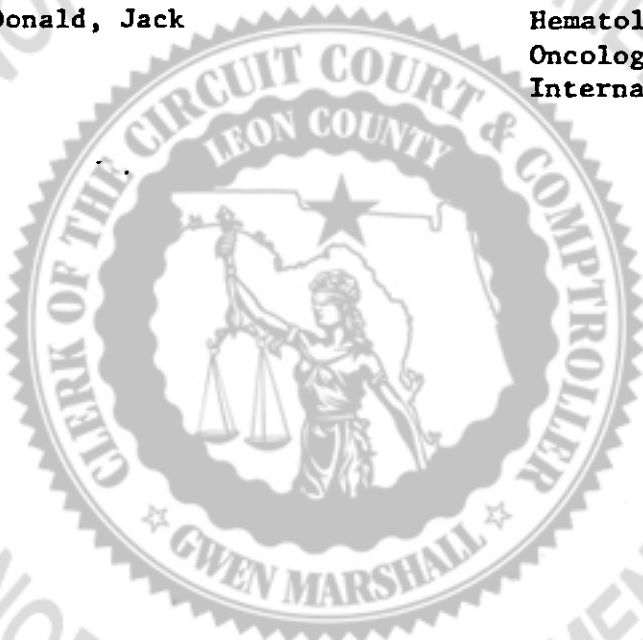

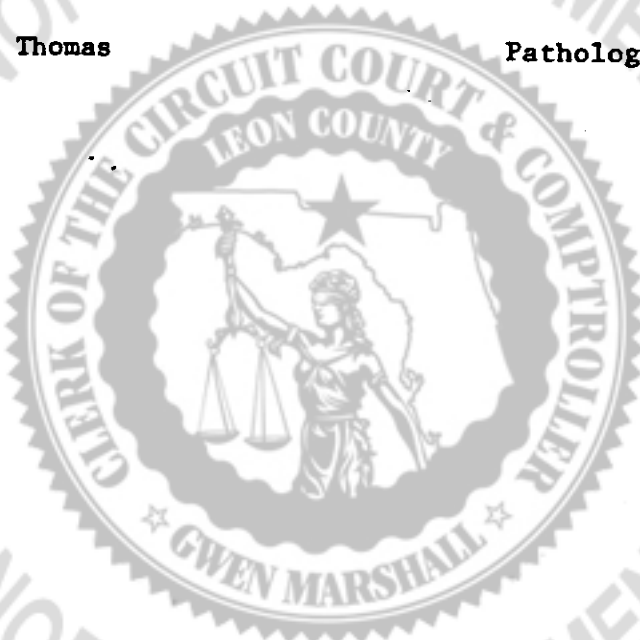
