

Reporter, vice Sue Habershaw, resigned

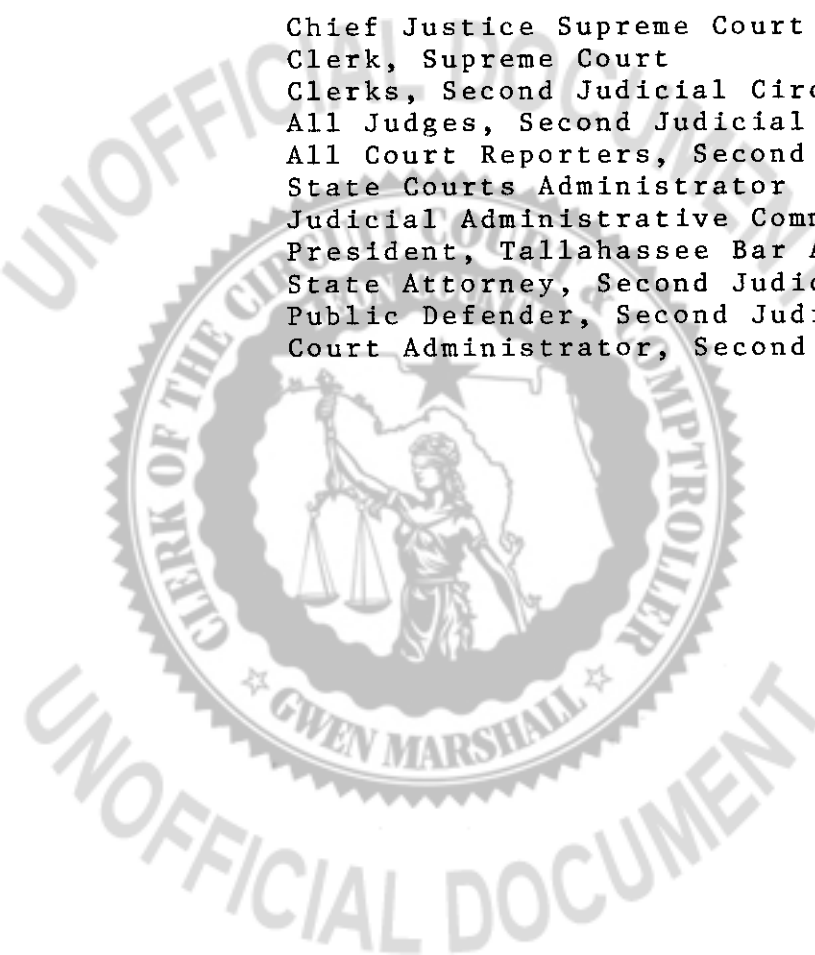
Pursuant to and in compliance with Chapter 29, Florida
