ADMINISTRATIVE ORDER NO. 83-1

IN RE: Selection and Certification of Prospective  
Statewide Grand Jurors from the Second Judicial Circuit,  
pursuant to Chapter 73-132, Laws of Florida, 1973,  
(F.S. 905)

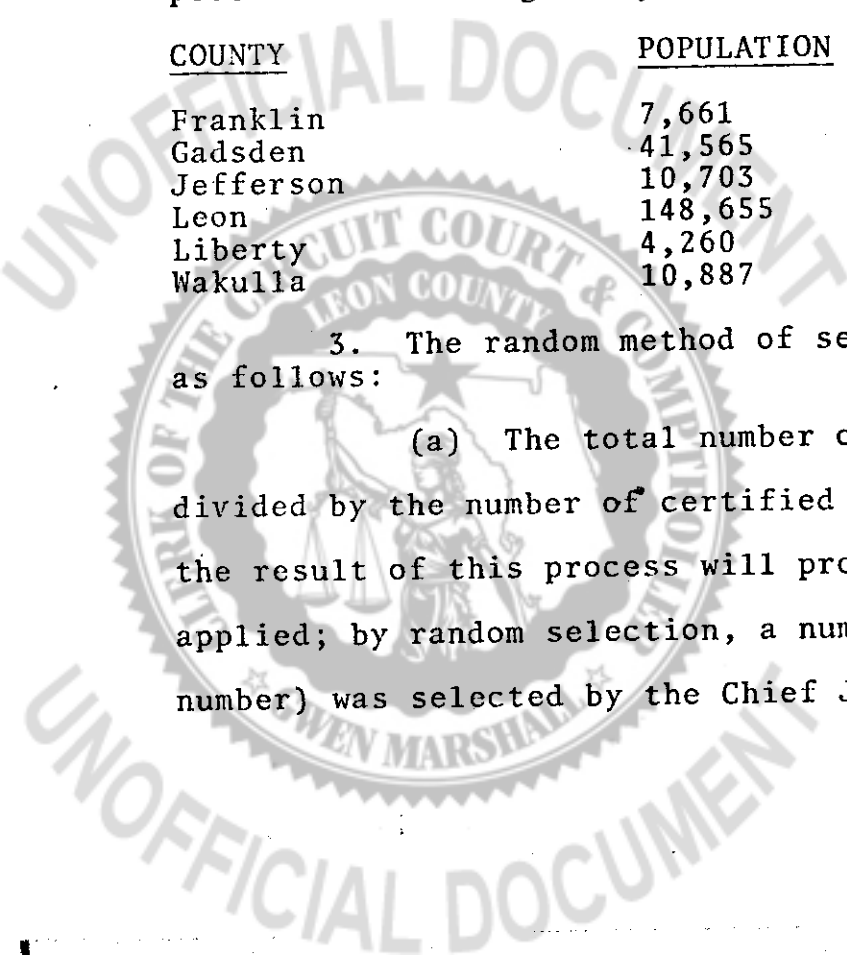
1. In accordance with the requirements of F.S. 905, as embodied in Section 1, Chapter 73-132, Laws of Florida, 1973, the undersigned Chief Judge of the Second Judicial Circuit has caused to be compiled a list of persons called for and certified for jury duty in each of the several counties of this Circuit. From such lists the said Chief Judge has selected by lot and at random a list of eligible prospective statewide grand jurors on the basis of three such jurors for each 3,000 residents, or fraction thereof, in each county, and such list is herewith submitted to the State Courts Administrator in compliance with said Statute.

2. The number of residents in each county for the purposes of this Order are drawn from the 1980 official Florida State and Federal Census as published on page 1009, Volume 4, Florida Statutes, 1981. From such source, and applying the formula mentioned in said Chapter 73-132, it is found that the counties of this Circuit shall yield respectively the following numbers of prospective statewide grand jurors:

Franklin	7,661	9
Gadsden	41,565	42
Jefferson	10,703	12
Leon	148,655	150
Liberty	4,260	6
Wakulla	10,887	12

3. The random method of selection in each county has been as follows:

(a) The total number on the list of each county was divided by the number of certified jurors required for each county; the result of this process will produce the sequence number to be applied; by random selection, a number (1 thru the last sequenced number) was selected by the Chief Judge, which number was that of



the juror listed from the beginning of the list and which constitutes the first juror selected.

(b) Thereafter, jurors were selected as their names appeared opposite successive sequence numbers applied from the name of the juror opposite the random number drawn.

4. The names so selected with their counties and addresses are shown in the following attachments.
