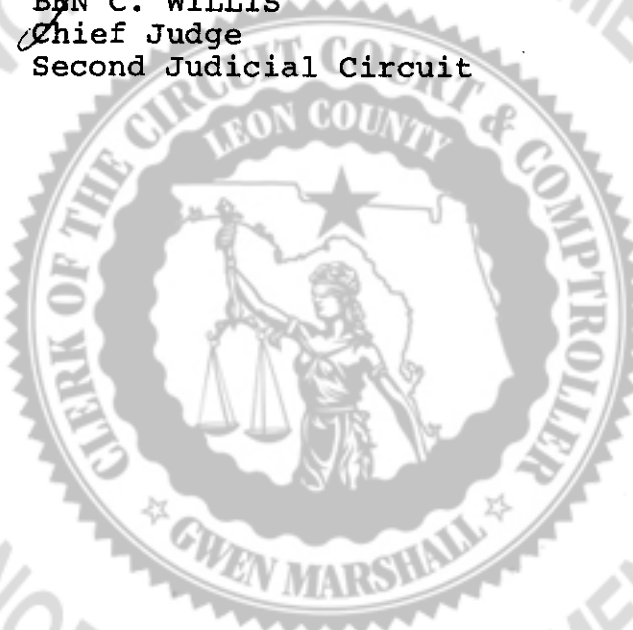

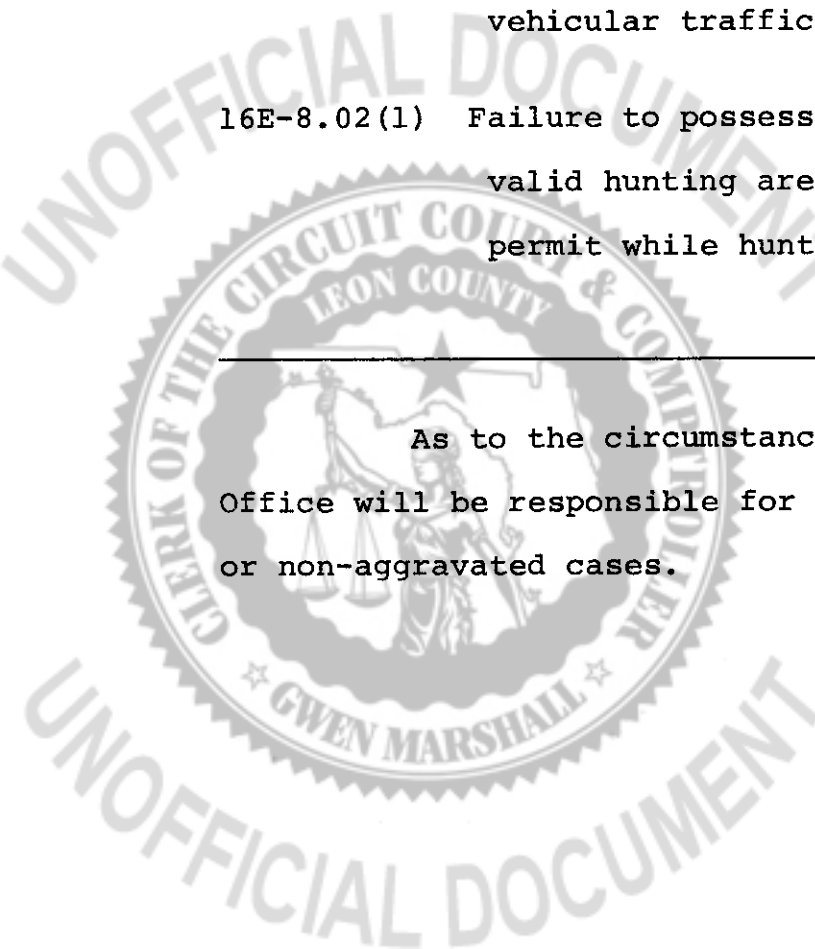


Upon the express recommendation of the State Attorney's Office, you are hereby authorized to dismiss the following types of cases:
