


ADMINISTRATIVE ORDER

AMENDED ADMINISTRATIVE ORDER NO. 12

RE: BOATING LAW


PURSUANT to Chapter 78-181, Laws of Florida, 1978, effective October 1, 1978, all infraction citations resulting from a violation of Section 371.68, Florida Statutes, shall be filed by the Law Enforcement Officer issuing the citation with the Traffic Division of the Leon County Court.

ANY PERSON receiving such a citation may pay at the Traffic Violation Bureau window a fine of twenty-five dollars (\$25.00) after the entry of a plea of guilty to said violation. Should the person receiving the citation wish to enter a plea of not guilty the case shall be set before a Judge of the Leon County Court, said violation hearing to be scheduled in accordance with other non-criminal traffic infraction hearings involving violations of Chapter 316, and 318, Florida Statutes.

UPON conviction of any violation of this law, a five percent (5%) surcharge shall be levied on any fine, civil penalty or forfeiture as provided by Section 142.01, Florida Statutes, and shall be deposited in the Crimes Compensation Trust Fund.
