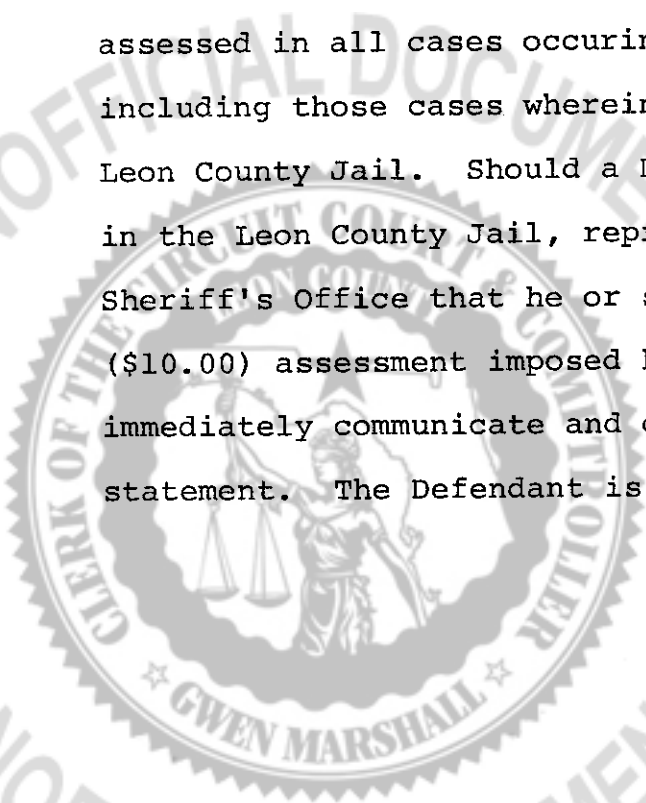
ADMINISTRATIVE ORDER NO. 7

THE Florida Legislature inacted Senate Bill 89 into law amending Section 960.18, Florida Statutes, in the 1980 Legislative Session. The effective date of the law is contained in Section 22 of the before mentioned bill and is July 1, 1980.

IN setting up the Administrative Procedures to apply with the law so inacted this court directs the Clerk of the County Court in and for Leon County in conjunction with the Sheriff's Office in and for Leon County to collect the Victims Crimes Compensation Assessment in compliance with Section 775.0835 (3), Florida Statutes. This subsection requires that the fee for the Crimes Compensation Trust Fund be collected prior to any such fine or surcharge authorized by this Chapter.

WHEREFORE the fee imposed by Statute for the Crimes Compensation Trust Fund shall be collected by the Clerk of the County Court in and for Leon County and the Sheriff's Office in and for Leon County prior to the collection of any fines imposed by the Court and or Court costs or other assessments involving probationary fees.

SAID Crimes Compensation Trust Fund fee shall be assessed in all cases occurring on or after July 1, 1980, including those cases wherein the Court imposes a term in the Leon County Jail. Should a Defendant, after serving a sentence in the Leon County Jail, represent under oath to the Leon County Sheriff's Office that he or she does not have the ten dollar (\$10.00) assessment imposed herein the Sheriff's Office shall immediately communicate and deliver to this Court said sworn statement. The Defendant is to be released after serving the



appropriate time even though said Defendant does not have the ten dollars (\$10.00) for the Victims Crime Compensation Trust Fund.

UPON notification by the Sheriff's Office of the failure of the Defendant to pay the ten dollar (\$10.00) fee for the Victims Crime Compensation Trust Fund it shall become a lein against said Defendant and shall be dully recorded by the Clerk of the Circuit Court.
