ADMINISTRATIVE ORDER 83-1

CRIMINAL DIVISION

RE: Arraignment Dates and Docket
Sounding

BEGINNING on the 1st of April, 1983, Wednesday of each week will be set aside for arraignments to commence at 9:00 A. M.

DOCKET SOUNDING for both criminal and traffic criminal cases shall be held two times each month, beginning at 9:00 A. M. At the Docket Sounding the presiding Judge may also accept pleas of guilty or nolo contendere and pronounce sentence or otherwise dispose of a specific case.

ONE DAY is set aside in each month for the trial of Non-Jury Criminal cases.

ALL CRIMINAL Jury Trials shall commence at 9:00 A. M. Eight criminal jury trial days shall be scheduled each month. Four criminal traffic jury trial days shall be scheduled each month. All Criminal Division matters shall be disposed of in the Leon County Courthouse. All traffic jury trials shall be tried in the Leon County Courthouse.

1) At the time it becomes necessary to set a court date for a defendant, give the defendant a court date for the second Wednesday following the defendant's arrest. If an arrest occurs on a Wednesday, do not include the arrest day in your computation. The only exception occurs between 5:00 P. M. and 12:00 midnight on Tuesday. In that instance set the Court date for the third Wednesday following arrest.

2) The defendant may ask the Court for a continuance, but cannot ask a law officer for a continuance which defeats the guidelines for this order.

3) Further, the Clerk of the Court will be responsible for notifying all appropriate agencies of any Wednesday that the Court will be closed.

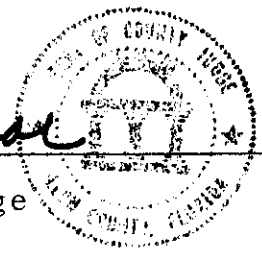
4) The purposes of the guidelines are to give the Clerk sufficient time to prepare for arraignments while also respecting the Defendant's Speedy Trial right. The guidelines are to be adhered to by all parties who take part in setting arraignment dates, whether by a notice to appear or some other notice.
