ADMINISTRATIVE ORDER NO. 85-3

WHEREAS, the power to admit to bail is judicial, and

WHEREAS, standing judicial orders establishing bond amounts for specific criminal offenses are permitted, and sheriffs may administer such orders in a ministerial way under color of judicial authority, and

WHEREAS, it is the intent of this Court to permit the use of a standing judicial bail order only under criteria that will protect the citizens of Leon County, and,

WHEREAS, the Supreme Court of Florida has, by its Criminal Rules, provided for the first appearance detention hearing which ensures that no one will remain detained in this state for longer than twenty-four (24) hours without being brought before a judicial officer for the purpose of addressing the question of release in an individualized manner. It is therefore

ORDERED AND ADJUDGED that all existing bond schedules in effect in Leon County, Florida, including the one established by Administrative Order Number 79-5, and the one effective February 22, 1982, origin unknown, are hereby revoked.

It is further

ORDERED AND ADJUDGED that release from adult detention shall be based on either:

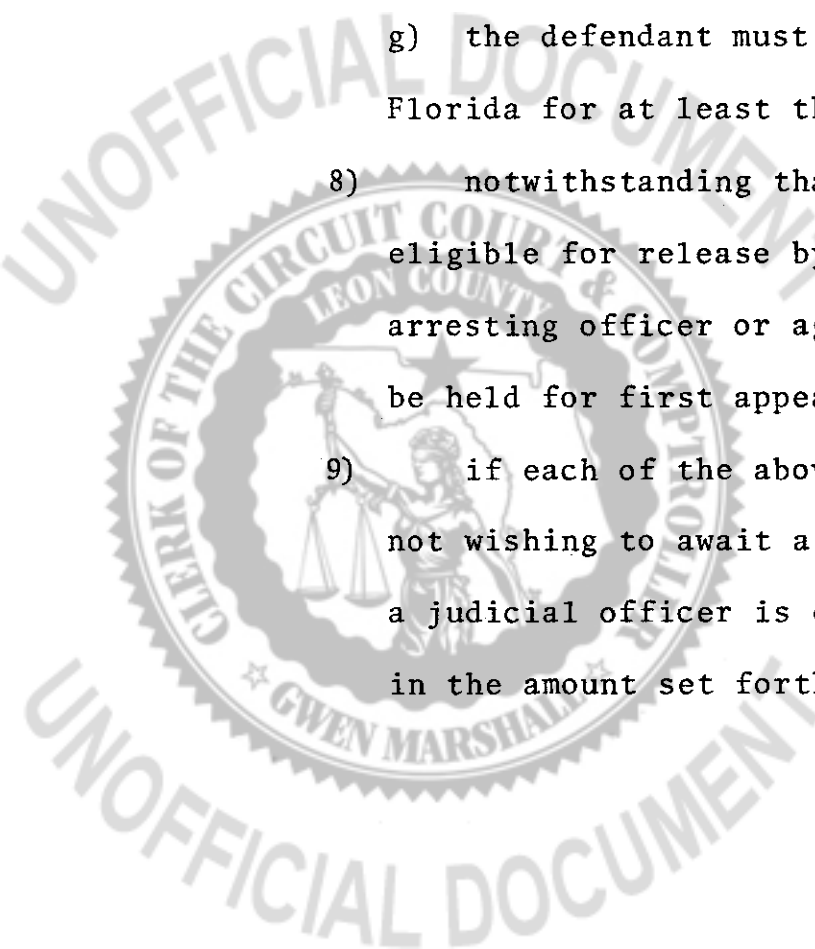
- 1) a notice to appear issued by the arresting officer as provided by law, or
- 2) by pre-set bail when the amount of bail or other condition of release is endorsed on a warrant or capias issued by a Judge of the County or Circuit Court, or
- 3) after written motion and order signed before this Court or the Circuit Court, or
- 4) after first appearance detention hearing, or
- 5) after hearing for the purpose of setting the conditions

of release from detention, or

6) by writ of habeas corpus or any other manner provided by law, or

7) by a pre-established bail schedule under the following conditions:

- a) the information on the defendant required by Administrative Order 85-2 must be available;
- b) If the present offense be a felony of any degree, the defendant must have no prior history of being found guilty of any felony, including withholding of adjudication;
- c) the offense charged must not carry a mandatory jail or prison sentence upon conviction (firearm, second DUI, etc.)
- d) if the present offense is a felony or a misdemeanor, the defendant shall have no past record of escape or failure to appear at any criminal proceeding;
- e) if the offense is a felony or misdemeanor, there must have been no firearm used, or other weapon as defined in Section 790.001, Florida Statutes;
- f) if the offense is a felony or misdemeanor, it must not involve a crime of violence against the person;
- g) the defendant must have resided continuously in Florida for at least the last past year;
- 8) notwithstanding that the defendant may otherwise be eligible for release by the posting of money bail, the arresting officer or agency may require that he or she be held for first appearance;
- 9) if each of the above conditions are met, a defendant not wishing to await a first appearance hearing before a judicial officer is eligible to be admitted to bail in the amount set forth in the following schedule:

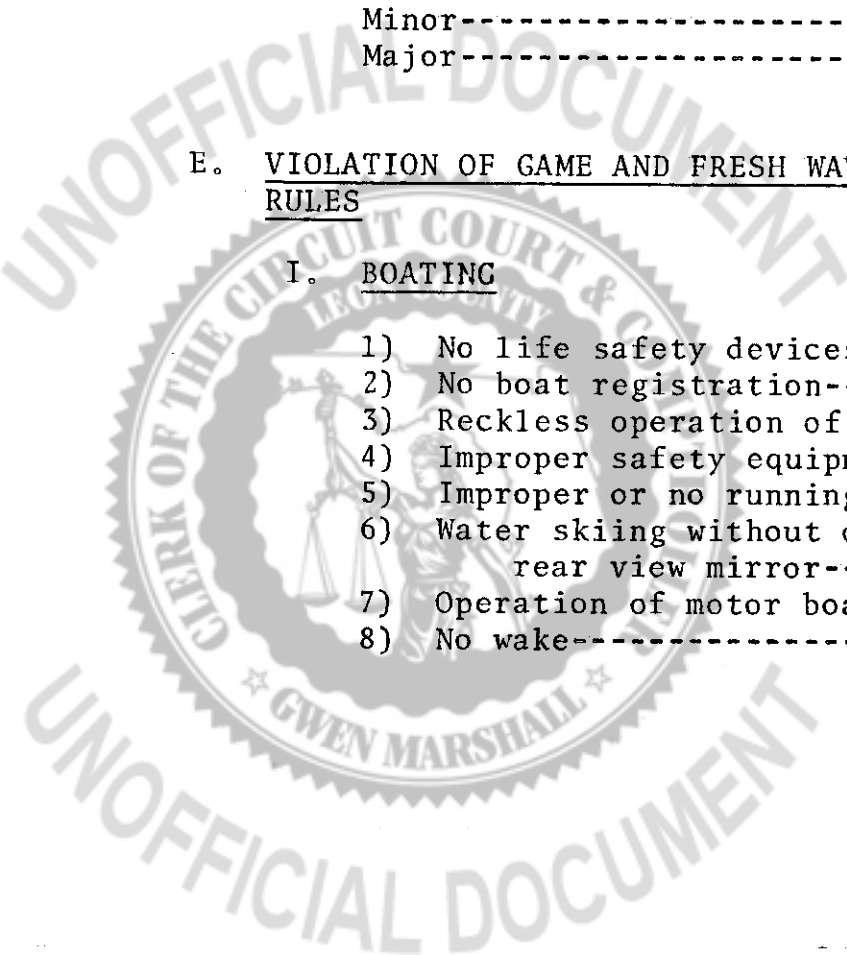

FELONY BOND SCHEDULE

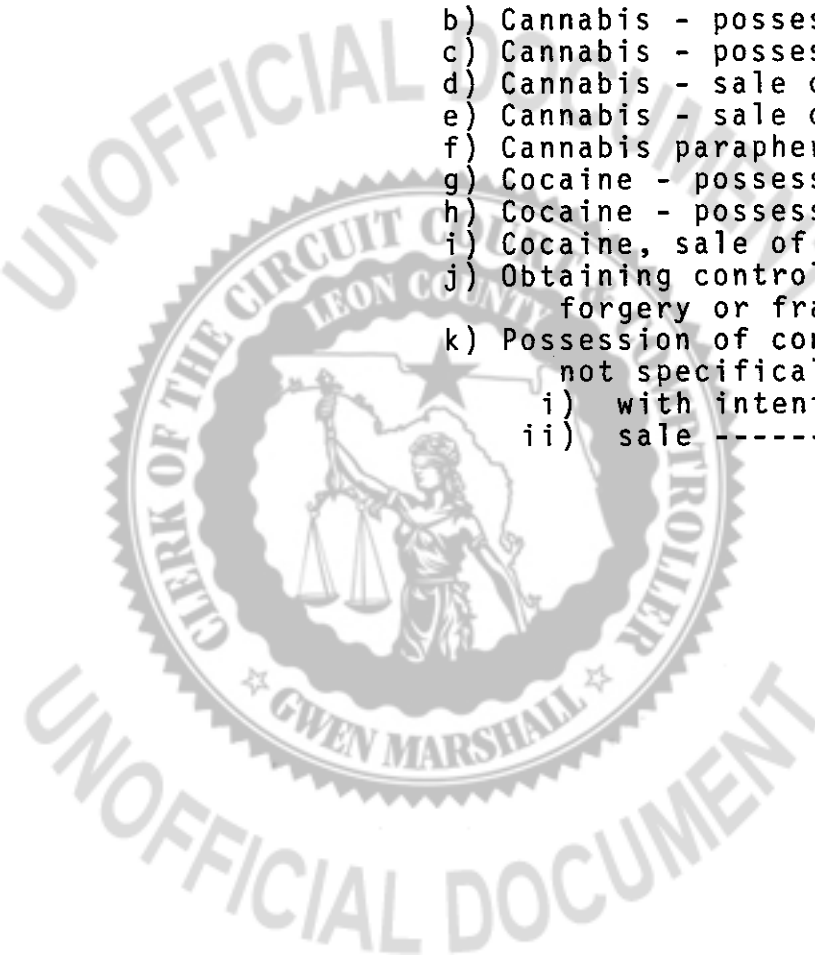
I. NO BOND OFFENSES AND MANDATORY FIRST APPEARANCE

NO BOND is to be allowed except by Circuit Court order on the following charges as these offenses are not bondable as of right unless after an adversary detailed evidentiary hearing the Circuit Court finds the proof of guilt is not evident nor is the presumption of guilt great:

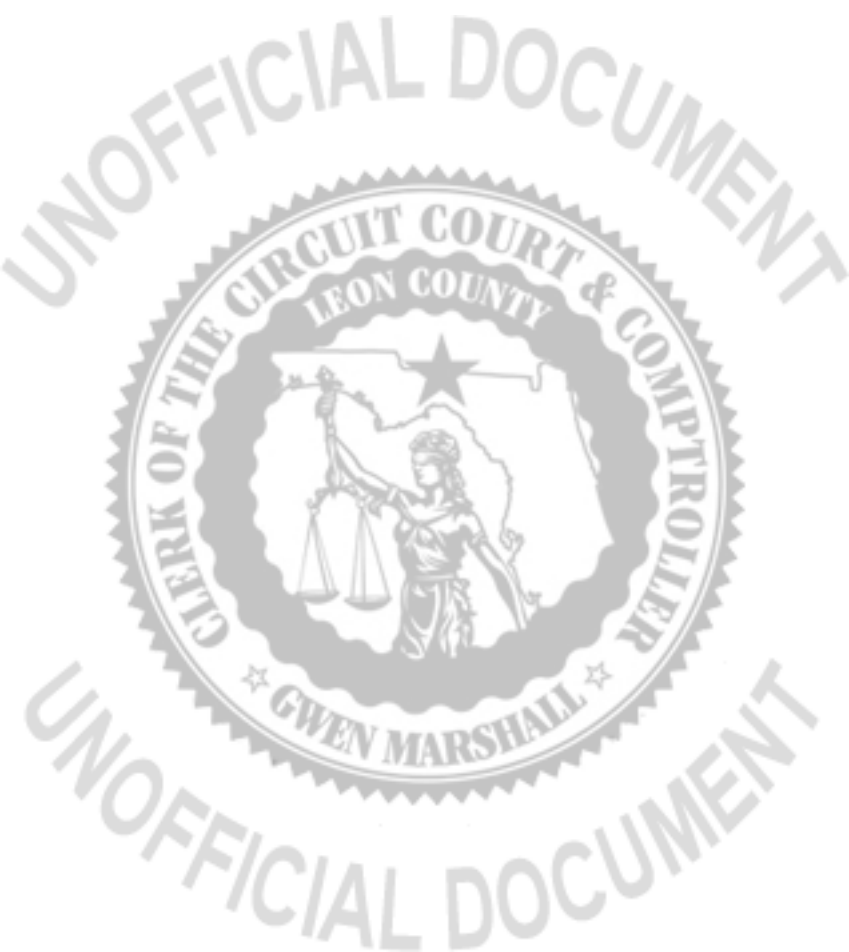
- A. Burglary if a firearm is possessed or stolen by the defendant or if any person is assaulted or injured by the defendant (LIFE)
- B. Escape from a prison or jail facility
- C. Kidnapping (LIFE)
- D. Murder (1st degree - capital or 2nd degree - LIFE)
- E. Armed Robbery (LIFE)
- F. Sexual Battery
  - a) victim under 11 years (CAPITAL)
  - b) deadly weapon used or threatened (LIFE)




