ADMINISTRATIVE ORDER NO. 2005-05

**IN RE: APPOINTMENT OF GORDON DAVID CHERR AS CHILD SUPPORT
ENFORCEMENT HEARING OFFICER, SECOND JUDICIAL CIRCUIT.**

WHEREAS, the Florida Department of Revenue has provided funding to establish a child support enforcement hearing officer program;

WHEREAS, the the child support enforcement hearing officer program includes all counties in the Second Judicial Circuit;

IT IS THEREFORE

ORDERED THAT:

1. A full-time child support enforcement hearing officer program is hereby established to handle selected child support cases in the Second Judicial Circuit.
2. Gordon David Cherr, attorney at law, is hereby appointed as full-time child support enforcement hearing office in the Second Judicial Circuit.
3. Upon the filing of the cause of action or other proceeding for the establishment, enforcement, or modification of support by the Department of Revenue wherein the party seeking support is receiving services pursuant to Title IV-D of the Social Security Act (42 U.S.C. Section 1302), or not receiving services (non IV-D proceedings), the clerk of the court is hereby directed to refer such cases to the child support enforcement hearing officer.
4. All proceedings conducted before the child support enforcement hearing officer shall be reported by electronic recording methods pursuant to provisions of Fla.R.J.D. Admin. 2.070 (c).
5. The child support enforcement hearing officer shall perform such duties and possess such powers as enumerated with Fla. Fam. Law R.P. 12.490 and 12.491.
6. This order shall become effective immediately.
7. Administrative Order No. 2004-10 is hereby rescinded on this date.

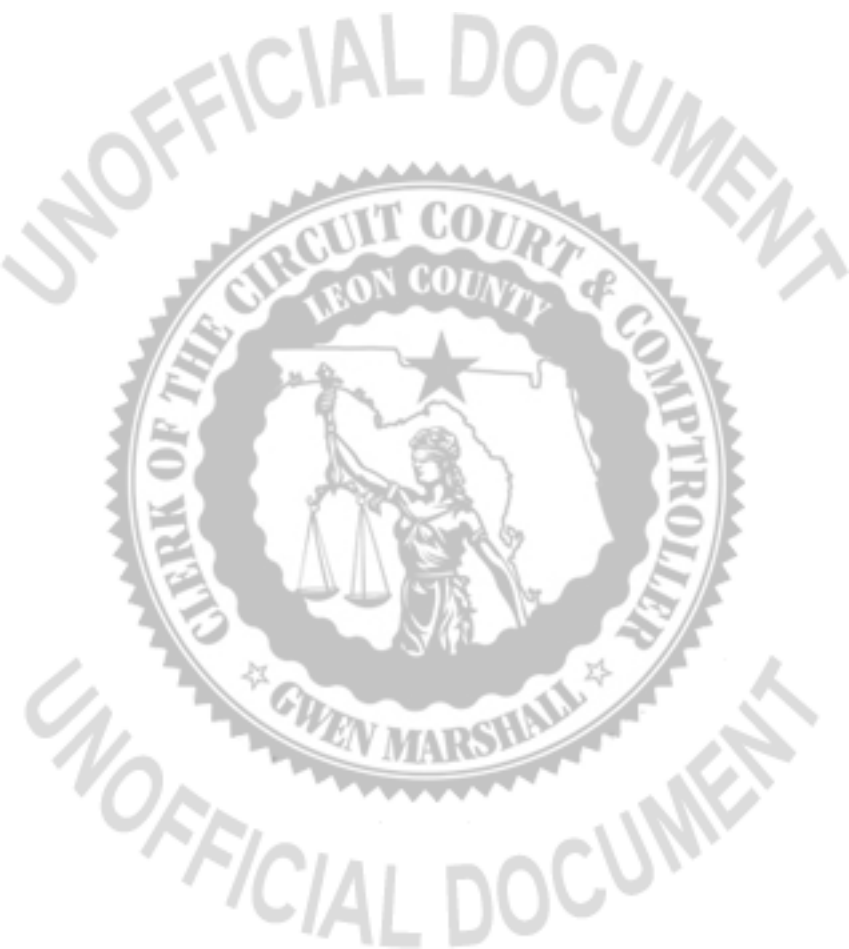
