ADMINISTRATIVE ORDER 2006-07

FIRST AMENDMENT

**IN RE: CIRCUIT JUDGE AND COUNTY JUDGE ASSIGNMENTS,
SECOND JUDICIAL CIRCUIT**

WHEREAS, Administrative Order 2006-07 sets forth the assignments for the judges of Second Judicial Circuit which shall take effect on January 2, 2007, and

WHEREAS, it is necessary to amend certain assignments set forth in the administrative order, it is therefore

ORDERED, that Administrative Order 2006-07 is amended as follows:

1. I. A. 5. of Administrative Order 2006-07 is amended to read as follows:

5. Special Assignment, Division E.

County Judges James O. Shelfer and Ronald W. "Ron" Flury shall be assigned all felony drug intervention cases and felony worthless check cases.

2. I. C. 5. of Administrative Order 2006-07 is amended to read as follows:

5. Special Assignments.

County Judge Augustus D. Aikens, Jr. shall be assigned all juvenile drug intervention cases. County Judges James O. Shelfer and Ronald W. "Ron" Flury shall be assigned all Simplified Dissolution of Marriage cases.

3. The last sentence of I. C. 6. of Administrative Order 2006-07 is amended to read as follows:

All judges and general magistrates shall assist each other in the orderly migration of cases in accordance with the assignments made herein and in the transition of workloads as assigned herein.

4. II. D. of Administrative Order 2006-07 is amended to read as follows:

D. General Magistrate Thomas W. Lager shall be assigned to assist Circuit Judge George S. Reynolds, III with the juvenile dependency cases, but only to the extent authorized by law and court rules. Administrative General Magistrate Dawn Caloca-Johnson shall be assigned to assist Circuit Judge George S. Reynolds, III with domestic relations cases as referred by Order of Referral to the General Magistrate.

5. VII. A. 4. of Administrative Order 2006-07 is amended to read as follows:

4. **Duties of Administrative Judges.**

Those judges designated administrative judges hereunder are expressly given the authority, consistent with this order and other applicable administrative orders, to assist with the administrative supervision of the designated court or division and to provide for duty coverage within the assigned division or court. No administrative judge is delegated the authority to enter any administrative order as that authority is reserved to the Chief Judge.

6. VII. B. of Administrative Order 2006-07 is amended to read as follows:

B. **Collections Court.**

County Judges James O. Shelfer and Ronald W. "Ron" Flury shall be assigned to all Leon County Collection Court cases.


7. X. of Administrative Order 2006-07 is amended to read as follows:

X. **SCHEDULING OF COURTROOMS AND HEARING ROOMS**

The scheduling of courtrooms and hearing rooms in Leon County shall be assigned by the Office of Court Administration under the supervision of the Chief Judge.
