FIRST AMENDMENT

IN RE: **CIRCUIT AND COUNTY COURT JUDGE ASSIGNMENTS,  
SECOND JUDICIAL CIRCUIT**

**WHEREAS**, Rule 2.050(b)(4), Florida Rules of Judicial Administration, provides that the Chief Judge shall assign judges to the courts and divisions and shall determine the length of each assignment, it is therefore

**ORDERED** that:

Section III of Administrative Order No. 2007-04 is amended to read as follows:

**III. WAKULLA COUNTY**

1. Circuit Judge N. Sanders Sauls shall be assigned all circuit criminal, civil, family, including juvenile delinquency and dependency cases, and probate cases, and all appeals from County Court.
2. County Judge Jill C. Walker is hereby assigned primary backup to handle dependency and delinquency cases.

Section 1.C.5 of Administrative Order No. 2007-04 is amended to read as follows:

5. Special Assignments.

County Judges James O. Shelfer, Timothy Harley and Ronald W. "Ron" Flury shall be assigned all simplified dissolution of marriage cases.

Section 1.E. of Administrative Order No. 2007-04 is amended to read as follows:

- E. County Court Criminal Division

County Judges Augustus D. Aikens, Jr., and Judith W. Hawkins shall be assigned to the County Court Criminal Division which shall include all pending and previously scheduled hearing and trial dates and times associated therewith.

1. County Judge Judith W. Hawkins shall be assigned to all Misdemeanor Cases.
2. County Judges Timothy Harley, Ronald W. "Ron" Flury and James O. Shelfer shall be assigned all Misdemeanor worthless check cases and may be assigned on a rotating basis as determined and assigned by the Administrative Judge of the County Court.
3. County Judge Augustus D. Aikens, Jr. shall be assigned to all Traffic Cases.

Section 1.F of Administrative Order No. 2007-04 is amended to read as follows:

6. First Appearances.

All First Appearances, except otherwise assigned weekend and holiday duty, shall be assigned to County Judges Timothy Harley, Ronald W. "Ron" Flury and James O. Shelfer or may be assigned on a rotating basis as determined and assigned by the Administrative Judge of the County Court.

Section 1.G. of Administrative Order No. 2007-04 is amended to read as follows:

G. County Court Civil Division

County Judges Timothy Harley, Ronald W. "Ron" Flury and James O. Shelfer shall be assigned to the County Court Civil Division, which shall include all pending and previously scheduled hearing and trial dates and times associated therewith, and shall rotate among themselves all Civil case dockets as designated by the Administrative Judge of the County Court.
