ADMINISTRATIVE ORDER NO. 2008-13


IN RE: APPOINTMENT OF ACTING STATE ATTORNEY

It is **FOUND, ORDERED** and **ADJUDGED** that:

1. State Attorney William N. Meggs will not be available temporarily to serve and execute the duties as the regular incumbent of the office of State Attorney in and for the Second Judicial Circuit of the State of Florida from midnight November 30, 2008, through midnight January 5, 2009.
2. Section 27.16, Florida Statutes, provides the circuit judge of the circuit full power and authority to appoint temporarily a prosecuting officer with full and complete authority to act in such capacity during the period of unavailability.
3. Any temporary unavailability of the regular incumbent with respect to the office of State Attorney in and for the Second Judicial Circuit of the State of Florida must be filled immediately in the interests of justice and the public welfare.
4. JACKIE LEE FULFORD is a member in good standing of the Florida Bar, is available for appointment, is eminently qualified and has consented to be temporarily appointed to serve as Acting State Attorney of the Second Judicial Circuit in and for the State of Florida during the period commencing at midnight November 30, 2008, through midnight January 5, 2009.

It is **FURTHER ORDERED** that **JACKIE LEE FULFORD** be and is hereby appointed Acting State Attorney of the Second Judicial Circuit in and for the State of Florida commencing at midnight, November 30, 2008, and will continue as Acting State Attorney until midnight, January 5, 2009. **JACKIE LEE FULFORD** shall, upon oath, faithfully execute and discharge the duties of the office of State Attorney of the Second Judicial Circuit in and for the State of Florida with full and complete authority under the laws of the State of Florida, as made and provided. The acts of the Acting State Attorney shall be in all respects as valid as a regularly appointed state attorney and she shall sign all indictments and other documents as "acting state attorney." The appointment as Acting State Attorney shall cease at midnight, January 5, 2009.
