

Upon the Court adjudicating a defendant guilty and imposing a split sentence, form "C" attached hereto shall be completed by the Clerk.

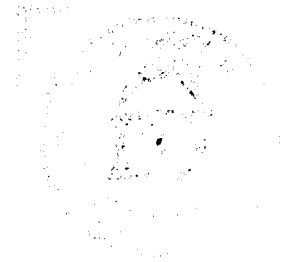
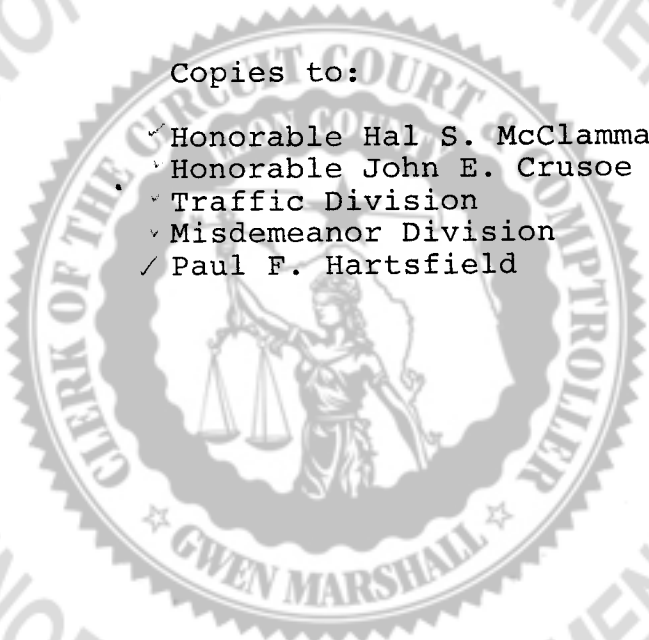
Where the Court withholds adjudication and places the defendant on probation, form "D" shall be completed.
