**ADMINISTRATIVE ORDER 2010 - 10  
FIRST AMENDMENT**

**IN RE: CIRCUIT JUDGE AND COUNTY JUDGE ASSIGNMENTS**

**WHEREAS**, Administrative Order 2010-10 currently sets forth the assignments for the judges of the Second Judicial Circuit; and

**WHEREAS**, Rule 2.215 (b)(40), Florida Rules of Judicial Administration, provides that the Chief Judge shall assign judges to the courts and divisions and shall determine the length of each assignment; and

**WHEREAS**, The Honorable N. Sanders Sauls has given the Governor notice of his resignation effective August 31, 2011, it is therefore

**ORDERED** that the judicial assignments set forth in Administrative Order 2010 - 10 are hereby amended as follows:

1. Item III.A. of Administrative Order 2010-10 is amended to read:

**III. WAKULLA COUNTY**

- A. Circuit Judge Jackie L. Fulford shall be assigned all circuit criminal cases, civil cases, family cases, including juvenile delinquency and dependency cases, probate cases, and all appeals from county court by assuming the case load previously assigned Circuit Judge N. Sanders Sauls, including all pending and previously scheduled hearing and trial dates, and times associated therewith. Circuit Judge Jackie L. Fulford is expressly cross-assigned to assist or handle any and all matters with or for Circuit Judge N. Sanders Sauls between the date of this order and the effective date her assignment.



2. Item VII.3.e. of Administrative Order 2010-10 is amended to read:

VII. MISCELLANEOUS ASSIGNMENTS

3.e. Circuit Judge Jackie L. Fulford is hereby designated Administrative Judge in Wakulla County for the purpose of coordinating Family Division case matters in the county.

3. Circuit Judge Jackie L. Fulford shall retain her Leon County Circuit Civil assignment until further order. Circuit Judges Terry P. Lewis, James O. Shelfer and Charles A. Francis are specifically cross-assigned to handle and assist with the Leon County Circuit Civil assignment of Jackie L. Fulford as directed by the Chief Judge. All counsel and parties desiring to schedule matters in Circuit Judge Jackie L. Fulford's Leon County Circuit Civil assignment shall continue to schedule through her Leon County office at (850)577-4305, and not through the Wakulla office.

4. Except as expressly amended or modified herein, all of the terms and provisions of Administrative Order 2010-10 shall remain in full force and effect.

5. This order shall be effective September 1, 2011.
