**ADMINISTRATIVE ORDER 2018-04
SIXTH AMENDMENT**

IN RE: CIRCUIT AND COUNTY JUDGE ASSIGNMENTS

WHEREAS, Administrative Order 2018-04, In Re: Circuit Judge and County Judge Assignments, as amended five times, currently sets forth the assignments for the judges of the Second Judicial Circuit of Florida; and

WHEREAS, Rule 2.215(b)(4), Florida Rules of Judicial Administration, provides that the Chief Judge shall assign judges to the courts and divisions and shall determine the length of each assignment, it is therefore

ORDERED that the following amendments to the judicial assignments for the Second Judicial Circuit shall take effect on June 20, 2019 and shall remain in effect until modified by subsequent order.

Paragraph I.D.2. shall be amended as follows:

2. Baker Act and Marchman Act Cases. Leon County Judges Augustus D. Aikens, Jr., and Anthony B. Miller shall be assigned all Baker Act and Marchman Act proceedings on days assigned by the administrative judge for the Leon County Court.

Paragraph I.D.3. shall be added:

3. Risk Protection Order Cases. Leon County Judges Augustus D. Aikens, Jr., shall hear all Risk Protection Order cases that come before the court during regular business hours.

Paragraph I.E. shall be amended as follows:

E. Leon County Court Criminal Division. County Judges Augustus D. Aikens, Jr., Nina Ashenafi-Richardson, Anthony B. Miller, Monique Richardson, and J. Layne Smith shall be assigned to the County Court Criminal Division, which shall include all pending and previously scheduled hearing and trial dates and times associated therewith, as follows:

Paragraph I.E.3. shall be amended as follows:

3. County Judge Anthony B. Miller shall be assigned twenty percent (20%) of all criminal cases. Judge Anthony B. Miller shall also be assigned all cases on the Leon County Court mental health criminal court docket, by assuming the case load previously assigned to Judge Stephen Everett, including all pending and scheduled hearing and trial dates and times.

Paragraph I.G. shall be amended as follows:


G. Leon County Court Civil Division. County Judges Augustus D. Aikens, Jr., Nina Ashenafi-Richardson, Anthony B. Miller, Monique Richardson, and J. Layne Smith shall be assigned to the County Court Civil Division, which shall include all pending and previously scheduled hearing and trial dates and times associated therewith, as follows:

Paragraph I.G.3. shall be amended as follows:

3. County Judge Anthony B. Miller shall be assigned twenty percent (20%) of all civil cases.

Circuit and county judges throughout the Second Judicial Circuit are authorized to supplement and aid any other circuit or county judge in the circuit when the circuit or county judge is unavailable, otherwise requests assistance, or is assigned by the Chief Judge.
