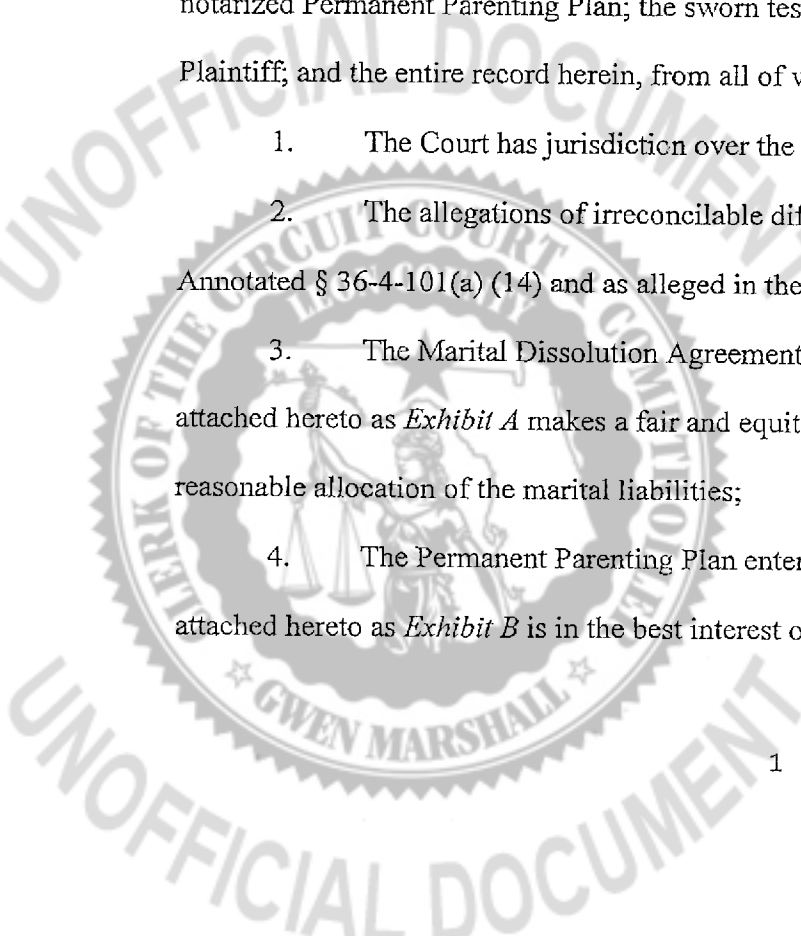

FINAL DECREE OF DIVORCE

This cause came to be heard on the 22nd day of August, 2017 before the Honorable Hollingsworth Judge of the Circuit Court in the Eleventh Judicial District, upon a Divorce Complaint; a signed and notarized Marital Dissolution Agreement; a signed and notarized Permanent Parenting Plan; the sworn testimony of Plaintiff; statements of counsel for Plaintiff; and the entire record herein, from all of which the Court finds as follows:

1. The Court has jurisdiction over the parties and over the subject matter of this case;
2. The allegations of irreconcilable differences set forth in Tennessee Code Annotated § 36-4-101(a) (14) and as alleged in the Divorce Complaint are sustained;
3. The Marital Dissolution Agreement entered into by and between the parties and attached hereto as *Exhibit A* makes a fair and equitable division of the marital assets and reasonable allocation of the marital liabilities;
4. The Permanent Parenting Plan entered into by and between the parties and attached hereto as *Exhibit B* is in the best interest of the parties' minor children;



5. The deviation in the child support worksheet is found to be reasonable and appropriate, and the deviations is therefore in the best interest of the parties' minor children;

6. More than ninety (90) days has expired from the time of the filing of the Complaint for Divorce;

7. Plaintiff is not pregnant; and

8. All other statutory provisions have been complied with as a prerequisite to the granting of this judgment.

It is therefore


ORDERED, ADJUDGED, and DECREED that Plaintiff is granted an absolute divorce from Defendant on the grounds of irreconcilable differences pursuant to Tennessee Code Annotated § 36-4-101(a)(14), the bonds of matrimony are dissolved, and that the parties are restored to all rights and privileges of unmarried individuals. It is further

ORDERED, ADJUDGED, and DECREED that the signed and notarized Marital Dissolution Agreement, that is attached hereto as *Exhibit A*, is fair and equitable and therefore approved by the Court and is incorporated herein verbatim and made a part of this Final Decree of Divorce as if the terms and conditions of the same were fully and completely set out herein. It is further

ORDERED, ADJUDGED, and DECREED that the signed and notarized Permanent Parenting Plan that is attached hereto as *Exhibit B*, is approved by the Court and is incorporated herein verbatim and made a part of this Final Decree of Divorce as if the terms and conditions of the same were fully and completely set out herein. It is further


ORDERED, ADJUDGED, and DECREED that the court costs are adjudged equally between the parties for which execution may issue if necessary.

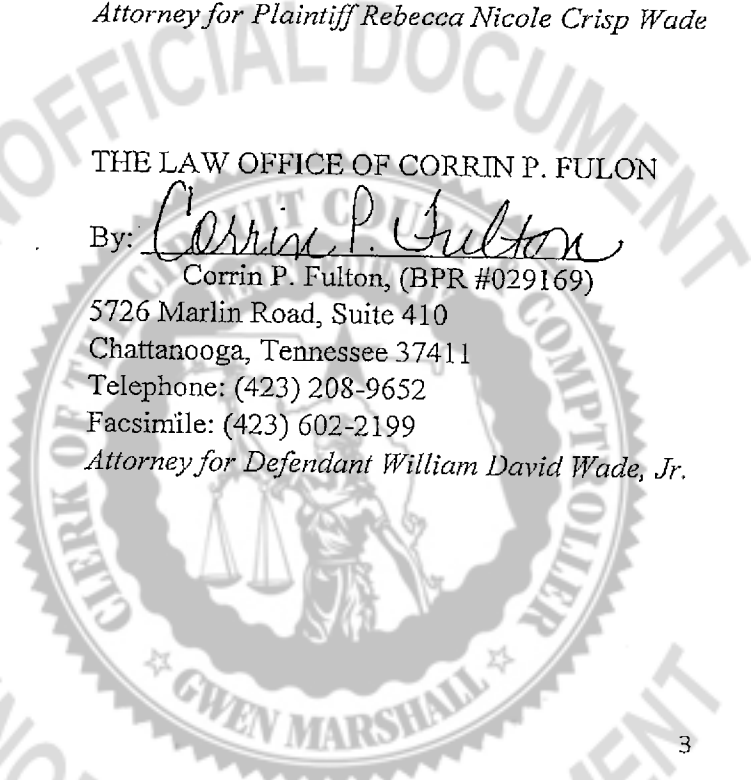
