**IN RE: SECOND JUDICIAL CIRCUIT PRO BONO COMMITTEE**

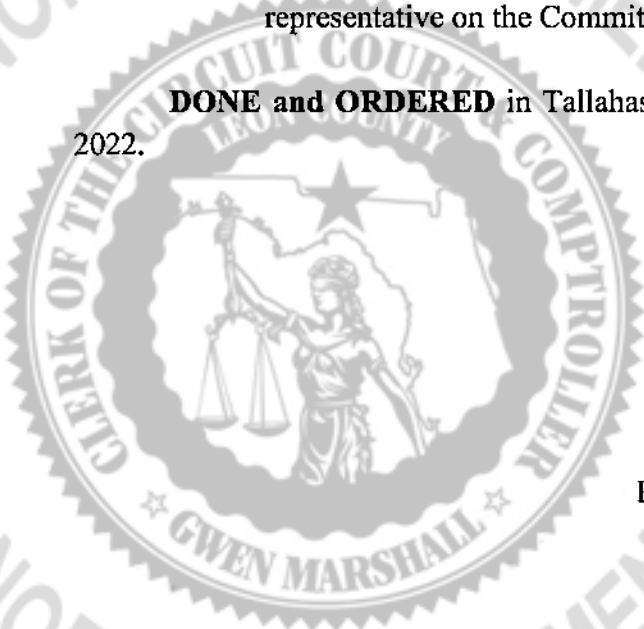
